EN**ANNEX**

Annexes IV, VI and VIII to Regulation (EU) No 142/2011 are amended as follows:

- (1) in Annex IV, Chapter IV, Section 3, point 2, the following point (g) is added:
- ‘(g) the methods for production of biodiesel from processed and rendered fats of Category 1, Category 2 and Category 3 materials, in accordance with Chapter IV, Section 2, points M and N, of this Annex, may be:
- (i) in the case of biodiesel resulting from the process, used as a fuel without restrictions under this Regulation (end point);
 - (ii) in the case of products other than biodiesel resulting from the methods:
 - disposed of in accordance with Article 12, points (a) or (b), Article 13 or Article 14 of Regulation (EC) No 1069/2009,
 - disposed of by burial in an authorised landfill,
 - transformed into biogas, provided the digestion residues from the biogas transformation of Category 1 material are disposed of by incineration, co-incineration or burial in an authorised landfill,
 - used for technical purposes referred to in Article 36, point (a)(i), of Regulation (EC) No 1069/2009.’;
- (2) in Annex VI, Chapter II, Section 2, point 1(a)(i), the following entry for Romania is inserted in the Table between the entries for Portugal and Slovakia:

- (3) in Annex VIII, Chapter V, point 3, the following point (f) is added:
- ‘(f) biodiesel produced from processed and rendered fats of Category 1, Category 2 and Category 3 materials, in accordance with Chapter IV, Section 2, points M and N, of Annex IV.’.
