Dear Secretary General,

I refer to the provisions of Protocol No 21 to the Treaty on European Union and to the Treaty on the Functioning of the European Union (on the position of the United Kingdom and Ireland in respect of the area of freedom, security and justice) and, in particular, Article 4 thereof, under which Ireland may at any time after the adoption of a measure by the Council pursuant to Title V of Part Three of the Treaty on the Functioning of the European Union notify its intention to the Council and to the Commission that it wishes to accept the measure.

I hereby notify you, in accordance with Article 4 of the above-mentioned Protocol, that Ireland wishes to accept and be bound by the following Regulations and Directive;
