Concerning notification under Article 2 of Council Framework Decision 2005/214/JHA

Under Article 2(1) of Council Framework Decision 2005/214/JHA of 24 February 2005 on the application of the principle of mutual recognition to financial penalties, each Member State is to inform the General Secretariat of the Council which authority or authorities, under its national law, are competent according to that Framework Decision when that Member State is the issuing State or the executing State.

The Ministry of Justice would point out that Section 289 of the Law on Administrative Liability lays down the procedure for Latvia to request the enforcement of a ruling on financial recovery in a Member State of the European Union.

In accordance with paragraph 1 of that Section, the institution whose official initially made the ruling on financial recovery must send that ruling, accompanied by the special form of certificate referred to in paragraph 2 of that Section, to a competent institution of a European Union Member State if it is impossible to enforce a ruling on financial recovery made in Latvia, as the place of residence of a sentenced person (in the case of a legal entity the registered legal address), or the property or income belonging to that person, is in another European Union Member State and if the determined financial recovery exceeds EUR 70.

In light of the above, we hereby provide information on the authorities that are entitled to send a decision on financial recovery to another Member State for enforcement in cases involving administrative offences, as well as information on Latvian courts of general jurisdiction that are entitled to receive decisions on financial recovery from other Member States of the European Union for enforcement (Annex).
