Subject:	Draft DIRECTIVE OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL on energy efficiency and amending Regulation (EU) 2023/955 (recast) (first reading)
	- Adoption of the legislative act

- On 14 July 2021 the <u>Commission</u> submitted its proposal¹, based on Article 194(2) TFEU, to the Council.
- 2. The <u>European Economic and Social Committee</u> delivered its opinion on 9 December 2021².
- 3. The <u>Committee of the Regions</u> delivered its opinion on 28 April 2022³.

- 4. On 11 July 2023 the <u>European Parliament</u> adopted its position at first reading on the Commission proposal. The outcome of voting in the European Parliament reflects the compromise agreement reached between the institutions and should, therefore, be acceptable to the Council⁴.
- The <u>Permanent Representatives Committee</u> is therefore asked to confirm its agreement and to suggest that the <u>Council</u> approve the European Parliament's position, as set out in PE-CONS 15/23, as an "A" item at a forthcoming meeting, with <u>Hungary</u> and <u>Poland</u>, voting against and <u>Latvia</u>, <u>Portugal</u> and <u>Slovakia</u> abstaining.
- 6. Should there be no Council meeting with quorum before 26 July 2023, the <u>Permanent</u> <u>Representatives Committee</u> is invited to decide, in accordance with the first subparagraph of Article 12(1) of the Council's Rules of Procedure, that the <u>Council</u> uses the written procedure for the adoption of the Directive of the European Parliament and of the Council on energy efficiency and amending Regulation (EU) 2023/955 (recast) as set out in PE-CONS 15/23.
- 7. The statements for the minutes of the Council meeting are set out in the <u>Addendum</u> to this note.
- 8. If the <u>Council</u> approves the European Parliament's position, the legislative act will be adopted.

After being signed by the Presidents of the European Parliament and of the Council, the legislative act will be published in the *Official Journal of the European Union*.
