Subject:	Management Board of the European Agency for Safety and Health at Work Appointment of Mr Argo SOON member for Estonia, in place of Ms Aija MAASIKAS, who has resigned

1. The General Secretariat of the Council has been informed of the resignation of Ms Aija MAASIKAS as a member of the Management Board of the above agency in the trade unions' representatives category (for Estonia).
2. Under Article 4 of Regulation (EU) 2019/126 of the European Parliament and of the Council establishing the European Agency for Safety and Health at Work (EU-OSHA), and repealing Council Regulation (EC) No 2062/94, members of the Management Board are appointed by the Council.

3. In accordance with the usual procedure, the trade unions' organisation ETUC has nominated the following candidate for this seat for the remainder of the current term of office, ending on 31 March 2023:

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EU) 2019/126 of the European Parliament and of the Council establishing the European Agency for Safety and Health at Work (EU-OSHA), and repealing Council Regulation (EC) No 2062/94¹, and in particular Article 4 thereof,

Whereas:

1. In its Decisions of 9 April 2019², 6 June 2019^{3,4} and 8 July 2019⁵, the Council appointed the members and alternate members of the Management Board of the European Agency for Safety and Health at Work for the period from 1 April 2019 to 31 March 2023.
2. A seat as member in the trade unions' representatives category has fallen vacant as a result of the resignation of Ms Aija MAASIKAS.
3. The trade unions' organisation ETUC has nominated a candidate for the vacant seat,
