In accordance with Art. 12(1) third subpar. of the [Council's rules of procedure](#) "A summary of acts adopted by the written procedure shall be drawn up every month by the General Secretariat. That summary shall contain any statements to be entered in the Council minutes. The sections of the summary which relate to adoption of legislative acts shall be made public."

² In the case of legislative acts adopted in the ordinary legislative procedure, there may be a difference between the date of adoption by the Council and the actual date of the act in question, since legislative acts adopted in the ordinary legislative procedure are only considered to have been adopted after signature by both the President of the Council and the President of the European Parliament and the Secretaries-General of the two institutions.
