DĖL INFORMACIJOS PATEIKIMO

Vadovaudamasi 2005 m. vasario 24 d. Tarybos pamatinio sprendimo 2005/214/TVR dėl abipusio pripažinimo principo taikymo finansinėms baudoms (toliau – pamatinis sprendimas) 2 straipsnio 1 dalimi, Lietuvos Respublikos teisingumo ministerija informuoja, kad Lietuvos Respublikoje nebeliko centrinės institucijos pagal pamatinio sprendimo 2 straipsnio 2 dalį. Lietuvos Respublikos Vyriausybė 2026 m. birželio 23 d. nutarimu Nr. 490 pripažino netekusiu galios pamatinį sprendimą įgyvendinančio Lietuvos Respublikos Vyriausybės 2008 m. kovo 5 d. nutarimo Nr. 219 „Dėl Lietuvos Respublikos teismų paskirtų piniginių sankcijų perdavimo vykdyti kitoms Europos Sąjungos valstybėms narėms taisyklių patvirtinimo“ 2 punktą, kuriuo buvo nustatyta, kad Lietuvos Respublikos teisingumo ministerija yra centrinė institucija, atliekanti pamatinio sprendimo 2 straipsnio 2 dalyje nustatytą funkciją – teikti pagalbą kompetentingoms institucijoms (teismams). Pažymėtina, kad pagal pamatinio sprendimo 4 straipsnio 5 dalį Lietuvos Respublikos kontaktiniai asmenys Europos teisminiame tinkle baudžiamosiose bylose ir toliau teiks pagalbą Europos Sąjungos valstybių narių kompetentingoms institucijoms, jeigu šioms nepavyks nustatyti kompetentingo Lietuvos Respublikos teismo.

Maloniai prašome perduoti šią informaciją visoms Europos Sąjungos valstybėms narėms ir Europos Komisijai.

SUBJECT: NOTIFICATION OF INFORMATION

In accordance with Article 2(1) of Council Framework Decision 2005/214/JHA of 24 February 2005 on the application of the principle of mutual recognition to financial penalties ('the Framework Decision'), the Ministry of Justice of the Republic of Lithuania hereby informs you that there is no longer a central authority within the meaning of Article 2(2) of the Framework Decision in the Republic of Lithuania. By Resolution No 490 of 23 June 2026, the Government of the Republic of Lithuania repealed point 2 of Resolution No 219 of the Government of the Republic of Lithuania of 5 March 2008 approving the rules on the transmission to other EU Member States of financial penalties imposed by the courts of the Republic of Lithuania for enforcement, which implements the Framework Decision; point 2 of the Resolution had established that the Ministry of Justice of the Republic of Lithuania was the central authority performing the function described in Article 2(2) of the Framework Decision of providing assistance to competent authorities (courts). It should be noted that, in accordance with Article 4(5) of the Framework Decision, the Republic of Lithuania's contact points in the European Judicial Network in criminal matters will continue to provide assistance to the competent authorities of the Member States of the European Union if they are unable to identify the competent court in the Republic of Lithuania.

We kindly ask you to forward this information to all Member States of the European Union and to the European Commission.
