## EEAS (2022) 1498

### Overview of the training areas and Training Requirements Analysis

Until August, 31<sup>st</sup> 2022 the EUCTG approved work plans for 20 civilian training areas and endorsed nineteen TRAs.

Three further work plans are to be submitted by the CCTs for approval.

Two offers from Member States are to be endorsed by EUCTG.

For seven civilian training areas, CPCC did not receive offers from Member States to take over as CCT.
