STATEMENT 60/03

Re Article 1

"The Austrian, Belgian, Danish, Spanish, Finnish, French, Greek, Italian, Netherlands, Portuguese and Swedish delegations and the Commission state that this Decision is a purely non-fiscal measure aiming at the improvement of the functioning of the internal market.

Any fiscal aspects related to the use of the computerised system for the movement and surveillance of excisable products (EMCS) will require the adoption of the appropriate amendments of the Council Directive 92/12/EEC, in accordance with the provisions of the Treaty. This decision does not prejudice the legal basis of any future amendments of Directive 92/12/EEC".

STATEMENT 61/03

Re Article 1

"The IRL and UK delegations, having regard to the origins of the Decision in the report of the High Level Group on Fraud, to the Commission's communication to the Council on the measures needed to combat fraud in connection with excise duty and the fundamental purpose of the computerised system, cannot agree that the Decision is "purely non-fiscal". Ireland and the UK consider that it is a fiscal measure. As such it cannot have a legal base of Article 95 as the second paragraph of that article excludes fiscal provisions".

STATEMENT 62/03

Re Article 4(1)(b)

"The Council and the Commission state that the instruments for the exploitation of data to combat fraud will respect national legislation in this area."

STATEMENT 63/03

Re Article 4(1)(b)

"The Commission considers that the previous statement must not impede the further presentation of a Community initiative, aimed at creating a Community legal framework for the exploitation of data to fight fraud."

WITH REGARD TO THE DIRECTIVE ON TAXATION OF SAVINGS:

STATEMENT 64/03

1. "The Council reaffirms that the exchange of information, on as wide a basis as possible, is to be the ultimate objective of the European Union in line with international developments."

STATEMENT 65/03

2. "The Council considers that sufficient assurances have been obtained with regard to the application of the same measures applying the same procedures as the 12 Member States, or as Austria, Belgium and Luxembourg, in all relevant dependent or associated territories (the Channel Islands, Isle of Man, and the dependent or associated territories in the Caribbean) and asks the Member States concerned to ensure that all relevant dependent or associated territories will apply those measures from the date of implementation of the Directive, it being understood that, if and when Austria, Belgium and Luxembourg implement automatic exchange of information, any territory applying the withholding tax will also implement automatic exchange of information from the same date as those Member States."

DECLARATION 66/03

3. "The Council states that Chapter III with the exception of Articles 14 and 15 of the Directive will not apply to the new Member States."

STATEMENT 67/03

4. "The Council calls on the Commission to continue negotiations, in close conjunction with the Presidency of the Council, with the Swiss Confederation, the Principality of Liechtenstein, the Republic of San Marino, the Principality of Monaco, the Principality of Andorra and the United States of America, in order to press for the exchange of information as the ultimate objective of the European Community, and to report back to the Council by 31 December 2006 on the progress of those negotiations."

STATEMENT 68/03

5. "The Council also calls on the Commission, during the transitional period referred to in Article 10 of the Directive, to enter into discussions with other important financial centres with a view to the adoption by those jurisdictions of measures equivalent to those to be applied within the Community."

STATEMENT 69/03

6. "Austria states that the implementation of an automatic exchange of information requires, and the implementation of a withholding tax of 35% might require, the modification of the Austrian Constitution. Therefore the agreement of Austria to the relevant provisions is subject to approval by the Austrian Parliament."

WITH REGARD TO THE <u>DRAFT AGREEMENT WITH SWITZERLAND</u> ON SAVINGS TAXATION

STATEMENT 70/03

1. "The Council states that the draft agreement with Switzerland, as submitted by the Commission on 28 May 2003, including a provision concerning the competent authority in Gibraltar, constitutes the final offer for an agreement between the EU and this country.

The four elements of this agreement relating to Savings Taxation constitute also the basis for agreements between the European Union and Liechtenstein, Andorra, Monaco and San Marino."

STATEMENT 71/03

2. "The Council notes that the Community does not have exclusive competence to conclude an agreement with Switzerland on the tax treatment of dividends and of interest and royalty payments as mentioned in Article 15 of the draft agreement. Delegations agree nevertheless, by way of exception and without creating a precedent, that Member States will not exercise their competence in this particular case."

STATEMENT 72/03

3. "The Council and the Commission declare that the exercise of competence by the Community in respect of Article 15 of the agreement with Switzerland does not affect existing bilateral agreements with other third countries and Member States maintain their competence to conclude bilateral agreements with other third countries on the tax treatment of dividends and of interest and royalty payments between companies."

STATEMENT 73/03

4. "The Netherlands delegation states that, in its view, it is understood that the Member States maintain their competence to conclude more favourable bilateral agreements with Switzerland in the future on the tax treatment of dividends and of interest and royalty payments."

STATEMENT 74/03

5. "The Council encourages the Commission to finalise, in close conjunction with the Presidency of the Council, the draft agreements with the aforementioned European third countries as soon as possible."

WITH REGARD TO THE DIRECTIVE ON INTEREST/ROYALTIES

STATEMENT 75/03

"The Council and the Commission agree that the benefits of the Interest and Royalty Directive should not accrue to companies that are exempt from tax on income covered by that Directive."

STATEMENT 76/03

"The Council invites the Commission to propose any necessary amendments to this Directive in due time."

WITH REGARD TO THE CODE OF CONDUCT

STATEMENT 77/03

"The Council

- Welcomes the progress achieved by the Code of Conduct Group (Business Taxation) as set out in its report (7018/1/03 FISC 31 REV 1 (en)).
- Notes that the descriptions in Annex 1 of 14812/02 FISC 299, as updated by the descriptions in Annex A to 7018/1/03 FISC 31 REV 1 (en), form an agreed basis for the evaluation of rollback.
- Notes that the Code Group has considered the proposed revised or replacement measures of
 Member States and of dependent or associated territories for those listed in Annex C to
 SN 4901/99 against the established criteria of the Code of Conduct and, as set out in Annex B
 to 7018/1/03 FISC 31 REV 1 (en), has found that none of these are harmful within the
 meaning of the Code.
- Agrees that the proposed revised or replacement measures are adequate to achieve rollback of all the harmful features of the 66 measures listed in Annex C to SN 4901/99.
- Agrees to an extension of benefits beyond the end of 2005 as set out in paragraphs 15 and 17 of the Code of Conduct Group's report (7018/1/03 FISC 31 REV 1 (en)) and in paragraph 10 of the Annex to 5566/03 FISC 8.
- Approves the proposals for exchange of publicly available information arising from the Group's work on transparency and exchange of information, as set out in paragraphs 21 and 22 of 8848/02 FISC 129.

- Approves the proposals for the exchange of information in individual cases arising from the Group's work on transparency and exchange of information in the area of transfer pricing, as set out in 11077/02 FISC 208.
- Reaffirms its request to the Group to monitor standstill and the implementation of rollback and report to the Council by the end of the year."

STATEMENT 78/03

"The Swedish delegation declares that the rollback proposals concerning the tax measures that are referred to in the reservations from the Swedish delegation to the Code of Conduct Group's report (7018/03 FISC 31) are insufficient. Nevertheless, considering the importance of the fact that the tax package can be adopted, Sweden can accept the agreement as a whole."

STATEMENT 79/03

"The Council agrees, due to exceptional circumstances, to take a favourable Decision under Article 88(2) third subparagraph of the Treaty in response to the Belgian request regarding the Belgian Coordination Centres regime, which was submitted to the Council on 26 May 2003. The Council invites Coreper to take all necessary steps with a view to allowing the Council to adopt the envisaged Decision as soon as possible, and in any event before the end of June 2003."

STATEMENT 80/03

"The Austrian delegation recalls the necessity for a rapid adoption of the forthcoming Commission proposal with regard to cross-border leasing."

STATEMENT 81/03

Commission statement

"The Commission is ready, as it did in the past, to ensure that the Community market for tuna loins is adequately supplied, and for this purpose will make the necessary proposals before the expiry of the current TRQ".

STATEMENT 82/03

Commission statement

"The Commission will be carefully monitoring the situation of imports of canned tuna under the TRQ and, if the Commission considers that the EC market is being subjected to a high level of imports over a short period of time, would consider adopting appropriate measures under Article 8 of this Regulation."

STATEMENT 83/03

Statement by the Spanish delegation

"Spain reiterates its request that the Commission conduct a study evaluating the impact of the tarrif rate quota (TRQ) for imports of canned tuna on the Community market, which it considers adequately supplied, and on the deterioration in preferences for current ACP suppliers and other preferential countries."

STATEMENT 84/03

Statement by the United Kingdom delegation

"The United Kingdom has abstained on this proposal because it re-opens the possibility of very long distance transport of animals for slaughter. The United Kingdom would prefer a trade in carcase meat. The UK invites the Commission to consider this issue in the context of the forthcoming proposal on the welfare of animals in transport."

STATEMENT 85/03

Joint Council/Commission statement on Articles 3 and 3a

"In order to facilitate transborder access to information on companies, <u>the Council and the Commission</u> welcome any measures adopted by Member States aiming at setting up a common technological platform for electronic integrated access to the data contained in national registers."

STATEMENT 86/03

Council and Commission statement

"The Council and the Commission note that the present Directive, which only concerns action by the Commission, is not likely to require any adaptation to national legislation."

STATEMENT 87/03

Council and Commission statement

"The Council and the Commission state that the setting of an unallocated Community TAC of blue whiting available in the NEAFC Regulatory Area in 2003 is to be considered an ad hoc measure. Therefore, future allocation of this TAC in the NEAFC Regulatory Area in the different management areas should respect the principle of relative stability as set out in Regulation 2341/2002."

STATEMENT 88/03

Statement by the Commission and the Belgian, Danish, German, Greek, Spanish, French, Irish, Italian, Luxembourg, Netherlands, Austrian, Portuguese and United Kingdom delegations

"The Commission and the Belgian, Danish, German, Greek, Spanish, French, Irish, Italian, Luxembourg, Netherlands, Austrian, Portuguese and UK delegations further declare that catches of the unallocated TAC of blue whiting in the NEAFC Regulatory Area in 2003 shall not be taken into account when establishing a track record for future allocation of this TAC."

STATEMENT 89/03

Swedish statement on the setting of an unallocated Community TAC of blue whiting available in the NEAFC Regulatory Area in 2003

"Sweden considers the joint statement by thirteen Member States and the Commission on the setting of an unallocated Community TAC of blue whiting available in the NEAFC Regulatory Area to be in contradiction to established Community principles for the allocation of fishing possibilities and therefore not acceptable to Sweden.

Sweden has a real interest in the fishery for blue whiting in the NEAFC Regulatory Area. Future allocation of a new Community quota in these waters in ICES Areas I and II, where no allocation at present exists, must be considered as an establishment of new fishing opportunities in accordance with Article 20.2 of Regulation 2371/2002. In such circumstances the Council shall decide on the allocation of those opportunities, taking into account the interests of each Member State.

Stating that catches of the unallocated TAC of blue whiting, in any areas of the NEAFC Regulatory Area in 2003, should not be taken into account in future allocation of such a TAC is discriminatory and not in conformity either with Community legislation or with established practices for allocating fishing possibilities.

In order not to jeopardise the blue whiting stocks the Commission has during the last five years asked Member States to abstain from fishery of blue whiting in the NEAFC Regulatory Area. Sweden has abided by that request, although there would have been legal possibilities and a real interest by Swedish fishermen for conducting such a fishery. Stating that no consideration should be given to catches taken in the NEAFC Regulatory Area in 2003 for future allocations would thus also mean that Swedish fishermen will be punished for that responsible position taken by Swedish authorities."

STATEMENT 90/03

Council statement

"The Council acknowledges the particular importance, for the purpose of this Regulation, of the application of the general Community rules concerning control provided by Regulation No 2847/93 of 12 October 1993 establishing a control system applicable to the common fisheries policy."

STATEMENT 91/03

Council statement

(Article 2)

"The Council will ensure that, as far as possible, the terminology used for the exemptions specified in Article 2 of this Directive coincides with that to be used for the same exemptions under the future Regulation on the harmonisation of certain social provisions in the road transport sector."

Explanation of vote by Germany

"The Government of the Federal Republic of Germany is abstaining on the proposal for a Directive of the European Parliament and of the Council on the initial qualification and periodic training of drivers of certain road vehicles for the carriage of goods or passengers, because:

- it has not been possible to dispel general doubts concerning its compatibility with Article 150
 of the EC Treaty, and
- doubts also persist as to whether the Directive in its present form will have any positive economic effects, and in particular whether the burden which the Directive will impose on business, the citizen and the administration will be proportionate to the benefits the Directive is expected to provide."

UNTYING OF COMMUNITY AID

STATEMENT 92/03

Commission statement

"The European Commission, in its Communication of November 2002, presented to Council an approach to the untying of Community aid.

The Commission, taking into account the work of the OECD/DAC on untying, reaffirms its support for the concept of untying and its potential role in the improvement of development cooperation.

Based on the outcome of discussions in Council on this approach, the Commission will introduce legislative proposals, to provide a means to integrate the approach on untying of aid into all relevant legal bases of development-related financial instruments of the Community."

FINANCIAL FRAMEWORK

STATEMENT 93/03

COMMISSION STATEMENT (re Article 10(1), second sentence) on the amended proposal for a Regulation of the European Parliament and of the Council on aid for poverty diseases (HIV/AIDS, malaria and tuberculosis) in developing countries

"The Commission, in view of the priorities for 2004 and their consequences for the preparation of the programming of the Financial Perspectives for 2005-2006 set out in its Annual Policy Strategy decision of 5 March 2003 [COM (2003) 83 final], confirms that the increased financial framework for this Regulation (351 Meuro) can be accommodated within Heading 4 of the Financial Perspectives and, in particular, within the increased envelope foreseen for Activity Based Budget Policy Area Development. The Commission has, therefore, no intention to propose using the instruments provided for by the Interinstitutional Agreement of 6 May 1999 and, in particular, to propose mobilising funds over and above the current Heading 4 envelope."

STATEMENT 94/03

COMMISSION STATEMENT (re Article 10(1), second sentence) on the amended proposal for a Regulation of the European Parliament and of the Council on aid for policies and actions on reproductive and sexual health and rights in developing countries

"The Commission, in view of the priorities for 2004 and their consequences for the preparation of the programming of the Financial Perspectives for 2005-2006 set out in its Annual Policy Strategy decision of 5 March 2003 [COM (2003) 83 final], confirms that the increased financial framework for this Regulation (73,95 Meuro) can be accommodated within Heading 4 of the Financial Perspectives and, in particular, within the increased envelope foreseen for Activity Based Budget Policy Area Development. The Commission has, therefore, no intention to propose using the instruments provided for by the Interinstitutional Agreement of 6 May 1999 and, in particular, to propose mobilising funds over and above the current Heading 4 envelope."

STATEMENT 95/03

COUNCIL STATEMENT (re Article 10(1), second sentence) on the amended proposal for a Regulation of the European Parliament and of the Council on aid for poverty diseases (HIV/AIDS, malaria and tuberculosis) in developing countries

"The Council takes note of the statement by the Commission.

The Council states that its decision not to oppose the amendment proposed by the European Parliament in the Article fixing the Financial Framework in the Regulation on the possible use of the budget flexibility instrument provided for by the Interinstitutional Agreement of 6 May 1999 does not constitute a precedent.

The Council recalls that any decision to deploy the flexibility instrument will be taken jointly by the two arms of the budget authority in accordance with the voting rules under the fifth subparagraph of Article 272 (9) of the EC Treaty."

STATEMENT 96/03

COUNCIL STATEMENT (re Article 10(1), second sentence) on the amended proposal for a Regulation of the European Parliament and of the Council on aid for policies and actions on reproductive and sexual health and rights in developing countries

"The Council takes note of the statement by the Commission.

The Council recalls that any decision to deploy the flexibility instrument will be taken jointly by the two arms of the budget authority in accordance with the voting rules under the fifth subparagraph of Article 272 (9) of the EC Treaty."
