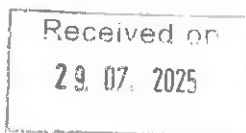

Dear President,

I refer to the provisions of Protocol No. 21 annexed to the Treaty on the European Union and to the Treaty on the Functioning of the European Union (on the position of the United Kingdom and Ireland in respect of the area of freedom, security and justice), and, in particular, Article 3(1) thereof, under which Ireland may notify the President of the Council in writing that it wishes to take part in the adoption and application of any such proposed measure.
