THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 305 thereof,

Having regard to Council Decision (EU) 2019/852 of 21 May 2019 determining the composition of the Committee of the Regions¹,

Having regard to the proposal of the German Government,

Whereas:

- (1) Pursuant to Article 300(3) of the Treaty, the Committee of the Regions is to consist of representatives of regional and local bodies who either hold a regional or local authority electoral mandate or are politically accountable to an elected assembly.
- (2) On 13 May 2025, the Council adopted Decision (EU) 2025/954², appointing the members and alternate members of the Committee of the Regions for the period from 13 May 2025 to 25 January 2030 and amending Decision (EU) 2025/71.
- (3) A member's seat on the Committee of the Regions has become vacant following the end of the national mandate on the basis of which Mr Volker-Gerd WESTPHAL was proposed for appointment.
- (4) The German Government has proposed Mr Markus NIGGEMANN, representative of a regional body who is politically accountable to an elected assembly, *Staatssekretär im Ministerium für Wirtschaft, Energie, Klimaschutz und Europa des Landes Brandenburg* (State Secretary in the Ministry for Economic Affairs, Energy, Climate Action and European Affairs of the State of Brandenburg), as a member of the Committee of the Regions for the remainder of the current term of office, which runs until 25 January 2030,

HAS ADOPTED THIS DECISION:

Article 1

Mr Markus NIGGEMANN, representative of a regional body who is politically accountable to an elected assembly, *Staatssekretär im Ministerium für Wirtschaft, Energie, Klimaschutz und Europa des Landes Brandenburg* (State Secretary in the Ministry for Economic Affairs, Energy, Climate Action and European Affairs of the State of Brandenburg), is hereby appointed as a member of the Committee of the Regions for the remainder of the current term of office, which runs until 25 January 2030.

Article 2

This Decision shall enter into force on the date of its adoption.
