The SCA took note of the state of play on this dossier (documents 11945/11 and 11980/11). The Special Committee also noted the view of the Council Legal Service that legal issues remained open on this dossier such as on the distinction to be drawn between Article 43(2) and Article 43(3) of the Treaty on the Functioning of the European Union and on which the Council Legal Service intends to prepare a written legal opinion, and on the use of urgency provisions under the delegated and implementing procedures respectively.
