### d) Detailed grounds for the decrease

In line with point 20 of the Inter-Institutional Agreement on the 2021-2027 Multiannual Financial Framework, amounts provided for in the budget for new fisheries agreements or for the renewal of fisheries agreements, which enter into force after 1 January of the financial year concerned, shall be included in reserve.

It is proposed to transfer an amount of EUR 3,5 million in commitment and payment appropriations from this reserve to the operational budget line 08 05 01 to cover the financial obligations resulting from the Protocols implementing the Sustainable Fisheries Partnership Agreements (SFPA) to be concluded with the Republic of Madagascar and with the Republic of Kiribati, as well as, to cover additional catches as set out in the relevant SFPA and Protocol for the Government of the Republic of Seychelles.

#### d) Detailed grounds for the increase

The reinforcement of the operational line by EUR 3,5 million in commitment and in payment appropriations is necessary to honour the 2023 financial obligations resulting from the new Implementing Protocols to the Fisheries Partnership Agreement between the European Union and the Republic of Madagascar (2023-2027) and with the Republic of Kiribati (2023-2028), as well as, to cover additional catches related to financial year 2023 as set out in the relevant SFPA and Protocol for the Republic of Seychelles.

As regards the Republic of Kiribati, following the Commission proposal COM(2023)251 of 16 May 2023, the Council is expected to agree on the conclusion and provisional application of the Implementing Protocol by 31 July 2023. The first access payment is due within 90 days following the entering into force of the Implementing Protocol after signature of both parties, which is expected by end of September.

Further to the Commission proposal to the Council (COM(2023) 219 of 28 April 2023) on the conclusion of a new protocol with the Republic of Madagascar, the Council decision, which serves as a legal basis for the signature was adopted on 26 June and the new Protocol entered into provisional application on 1 July 2023. The first access payment is due within 90 days following the entering into force of the Implementing Protocol.
