Having regard to the Treaty on the Functioning of the European Union, and in particular Articles 91(1), 100(2), Article 207(4), first subparagraph, Article 209(2) and Article 212, in conjunction with Article 218(6), second subparagraph, point (a), and Article 218(7), thereof,

Having regard to the proposal from the European Commission,

Having regard to the consent of the European Parliament<sup>1</sup>,

#### Whereas:

- In accordance with Council Decision .../...<sup>2+</sup>, the Partnership Agreement between the **(1)** European Union and its Member States, of the one part, and the Common Market of the South, the Argentine Republic, the Federative Republic of Brazil, the Republic of Paraguay and the Oriental Republic of Uruguay, of the other part (the 'Agreement') was signed on ... #### Article 1

The Partnership Agreement between the European Union and its Member States, of the one part, and the Common Market of the South, the Argentine Republic, the Federative Republic of Brazil, the Republic of Paraguay and the Oriental Republic of Uruguay, of the other part, is hereby approved on behalf of the Union.

### Article 2

For the purposes of Article 20.26 of the Agreement, any modification to or rectification of Annexes 20-A to 20-E to the Agreement shall be approved by the Commission on behalf of the Union, following consultation of the Trade Policy Committee.

### Article 3

- 1. For the purposes of Article 9.7(1), point (f)(ii), of the Agreement and Article 2(6) of Annex 10-D thereto, any amendment to Appendix 10-D-1 to that Annex shall be approved by the Commission on behalf of the Union, following consultation of the Trade Policy Committee.
- 2. For the purposes of Article 9.7(1), point (f)(iv), of the Agreement and Article 5(4) of Annex 10-D thereto, any amendment to Appendix 10-D-3 to that Annex shall be approved by the Commission on behalf of the Union, following consultation of the Trade Policy Committee.

## Article 4

For the purposes of Article 9.7(1), point (f)(x) to (xiii), and Article 21.39 of the Agreement, any amendment to Annexes 21-A, 21-B, 21-C and 21-E to the Agreement shall be approved by the Commission on behalf of the Union, following consultation of the Trade Policy Committee.

Article 5

This Decision shall enter into force on the day of its adoption.
