THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on European Union, and in particular Article 29 thereof,

Having regard to the proposal from the High Representative of the Union for Foreign Affairs and Security Policy,

Whereas:

- (1) On 26 July 2010, the Council adopted Decision 2010/413/CFSP¹ concerning restrictive measures against Iran.
- (2) The entry concerning one entity designated in Annex II to Decision 2010/413/CFSP should be updated.
- (3) Decision 2010/413/CFSP should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:
