STATEMENT BY CZECHIA

"While Czechia fully supports conclusion of an ambitious international instrument on plastic pollution, any legally binding provisions have to be practicable and implementable and, preferably, be based on existing Union initiatives.

In this context, we would like to express our concerns regarding the wording of the Bridge to Busan Declaration which in its last paragraph refers to freezing or restricting of primary plastic polymer production. Such measures could without thorough assessment have profound legal and practical implications. We would like to call upon the Presidency and the Commission to consider this in the upcoming negotiations."

Intergovernmental Organisation for International Carriage by Rail (OTIF) - letter on behalf of the EU and its Member States in response to China's application for accession to OTIF as an Associate Member Approval of a letter

STATEMENT BY SLOVAKIA

"The Slovak Republic appreciates the efforts made by the Presidency and the Commission in the search for a consensus within the Council on the EU's reaction to the Depositary Notification by the Secretary General of OTIF concerning the application of the People's Republic of China for accession to OTIF as an Associate Member.

It is for the purpose of maintaining unity and in a constructive spirit that we support the common EU approach and the proposed letter expressing an objection aimed at obtaining more time to consult, assess and reflect on the merits of the application.

We appreciate that the letter includes a reference that it is without prejudice to the future position of the EU and its Member States on the decision to be taken by the General Assembly of OTIF. The Slovak Republic sees a significant potential in the membership of the People's Republic of China in OTIF, which is also in line with the long-term strategy of OTIF. Based on the information currently available to us, we do not intend to object to the application of the People's Republic of China to become an Associate Member of OTIF."
