Ad "A" item 2: Regulation amending Regulation (EU) 2019/1009 as regards the digital

labelling of EU fertilising products

Adoption of the legislative act

STATEMENT BY ITALY

"The proposed Regulation for the digital labeling of EU fertilizer products is a tool that promotes the digitalization processes of the entire agricultural sector and will allow all industry operators to convey and manage information in an agile and efficient way. The proposal would appear to only partially support the evolution of the technological process - widely promoted by the entire agricultural sector - preventing the translocation of various information solely within the digital section. Furthermore, the use of this tool is currently under discussion also for other technical means for agriculture such as plant protection products, which are also fundamental to guarantee adequate agricultural production.

Therefore, considering that expanding the scope of digital labeling to all information other than safety requirements for human, animal, and environmental health would allow for better management of labels and packaging with a view to greater sustainability, it is hoped that the proposal can be subject to rapid updates to support the digital transition and to easily provide the farmer with complete and comprehensive technical information that is increasingly requested today."

STATEMENT BY SLOVAKIA

"According to the Slovak Republic, the introduction of the digital labelling of fertilizers brings opportunities to improve the reporting of information on the label. It brings technological progress, as well as contributes to reducing costs for fertilizer producers and the entire supply chain. For this reason, we regret that the final agreement of the co-legislators did not result in a more ambitious proposal that would lead to a more significant reduction of costs for economic operators, rationalization of labelling, reduction of packaging waste, and ultimately to a better use of digital labelling by operators. That would bring more benefits to the economics and environment."

STATEMENT BY THE COMMISSION

"The Commission expresses concern with the wording of the last sentence of recital 12 ("It is recalled that it is also essential that the end-user has the necessary information referred to in Regulation 2023/988 to be able to identify and contact the responsible person for products placed on the Union market.").

The Commission considers that Article 16 of Regulation 2023/988 [on general product safety], which lays down the obligation of establishment of a 'responsible person' for products placed on the Union market, does not apply to products subject to Regulation (EU) 2019/1009."
