Delegations will find attached a Commission staff working paper on the 2002 timetable for codification of the "acquis communautaire".

CODIFICATION OF THE ACQUIS COMMUNAUTAIRE

PLANNING as at 30 September 2002.

Since the launch of the project set out in the Commission's Communication of 21 November 2001 (COM (2001) 645 final) the Legal Service has made contact with all Directorates-General in order (i) to establish the acquis of each Directorate-General, (ii) to establish which acts are in principle codifiable, (iii) to establish an order of priority with regard to codifiable acts and (iv) to establish a working relationship.

In addition to the aforementioned framework, progress on the project which is due to be completed by the end of 2005 is conditional on the rate of progress in the consolidation of Community law by the Publications Office, which is due to be completed by the middle of 2003. The process of codification for non-consolidated acts will not normally begin before the summer and will therefore not be discussed by the legislative authority in 2002.

In view of the foregoing and given also that there is No way of knowing which acts will pose problems, the following is an <u>approximate</u> indication of the possible timetable, per Directorate-General, in relation to acts of the Council or of the Parliament and the Council ¹.
