 On 26 August 2025, the Commission submitted to the Council proposal for transfer of appropriations No DEC 13/2025, in accordance with Article 31(1) of the Financial Regulation<sup>1</sup>.

The purpose of this proposal is to transfer an amount of EUR 825 000 in commitment appropriations (c/a) and EUR 325 000 in payment appropriations (p/a) from Article 30 02 02 (Differentiated appropriations) to Article 08 05 01 (Establishing a governance framework for fishing activities carried out by Union fishing vessels in third-country waters), as recorded in document 12246/25.

- 2. The aim of this transfer is to cover the 2025 financial obligations resulting from the new Implementing Protocol to the Fisheries Partnership Agreement between the European Union and the Democratic Republic of São Tomé and Príncipe (2025-2029).
- 3. The <u>Budget Committee</u> examined the proposal for a transfer at its meeting on 12 September 2025.
- 4. Following that examination, the <u>Budget Committee</u> agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
  - the proposed transfer of appropriations, as set out in 12246/25; and
  - the draft letter in the ANNEX to this note.
