COUNCIL IMPLEMENTING DECISION

amending Implementing Decision (EU) 2024/1447 as regards the additional financial contribution from Norway

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2024/792 of the European Parliament and of the Council of 29 February 2024 establishing the Ukraine Facility¹, and in particular Article 20(2) thereof,

Having regard to the proposal from the European Commission,

Whereas:

- (1) Pursuant to Article 7 of Regulation (EU) 2024/792, it is possible for Member States, third countries, international organisations, international financial institutions or other sources to provide additional contributions to the Ukraine Facility, including to the Ukraine Plan.
- (2) Norway committed to provide NOK 1 000 000 000 as an additional financial contribution to Pillar I of the Ukraine Facility in the form of non-repayable financial support. That contribution constitutes external assigned revenue. The Commission is responsible for managing that contribution in accordance with the procedures applicable to the expenditure of the Union, in particular the procedures under Regulation (EU) 2024/792 and Regulation (EU, Euratom) 2024/2509 of the European Parliament and of the Council²
- (3) The financial contribution from Norway should be made available to Ukraine subject to the entry into force of a transfer agreement between Norway and the Commission and the transfer of the related financial contribution. That financial contribution should be allocated to the eleventh quarterly instalment of the Ukraine Plan and should be disbursed subject to the satisfactory fulfilment of the relevant qualitative and quantitative steps. The amount of the eleventh instalment of the Ukraine Plan should be adjusted accordingly to take into account the final amount of that financial contribution expressed in euro resulting from the application of the official exchange rate at the time of the transfer.
- (4) In the light of the situation in Ukraine and in order to ensure continuity in providing support to Ukraine, this Decision should enter into force as a matter of urgency on the

date of its publication in the *Official Journal of the European Union* and should apply from the date of its adoption.

- (5) Implementing Decision (EU) 2024/1447 should therefore be amended accordingly,
HAS ADOPTED THIS DECISION:

Article 1

Implementing Decision (EU) 2024/1447 is amended as follows:

- (1) in Article 2, the following paragraph 5a is added:

‘5a. An additional financial contribution, in the form of non-repayable support amounting to the equivalent in EUR of NOK 1 000 000 000 at the official exchange rate at the time of the transfer of the contribution by Norway to the Ukraine Facility, shall be made available to Ukraine pursuant to Article 7 of Regulation (EU) 2024/792.

The additional financial contribution referred to in the first subparagraph of this paragraph shall be implemented in accordance with the rules and conditions applicable to the amount referred to in paragraph 1 of this Article.’;

- (2) in the Annex, in the section entitled ‘Eleventh instalment (Q4 2026)’, the text between the title and the table is replaced by the following:

‘Total amount: EUR 2 103 225 808 and 1 000 000 000 NOK
Non-repayable support: EUR 270 000 000 and 1 000 000 000 NOK
Loans: EUR 1 833 225 808
Total number of steps: 23’.

Article 2

This Decision shall enter into force on the date of its publication in the *Official Journal of the European Union*.

It shall apply from the date of its adoption.
