Having regard to the Treaty on the Functioning of the European Union, and in particular Article 215 thereof,

### Article 1

The title of Regulation (EU) 2019/1890 is replaced by the following:

'Council Regulation (EU) 2019/1890 of 11 November 2019 concerning restrictive measures in view of Türkiye's unauthorised drilling activities in the Eastern Mediterranean'.

This Regulation shall enter into force on the day following that of its publication in the *Official Journal of the European Union*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
