Temporary reintroduction of border control at the  
internal borders of Estonia

Dear Madam/Sir


On 3 September Estonia will host the state visit of the President of the United States of America Mr Barack H. Obama and possibly host other heads of state from the region. The fact of the state visit became known to Estonian authorities less than four weeks before the visit.

Pursuant to the article 23 (1) and in accordance with Article 24 of regulation no 562/2006 of the European Parliament and of the Council establishing a Community Code on the rules governing the movement of persons across the borders and in accordance with the Estonian State Borders Act Article 11<sup>3</sup>, the Estonian Government with the regulation no 134 of the 21th of August 2014 decided to temporary reintroduce border controls at the internal borders of Estonia from 31th of August 2014 (02:00 PM; 14:00) until 3th of September 2014 (11:59PM; 23:59). The regulation also states, that the reintroduction of border controls will be ended as soon as possible when the President of the United States of America leaves the Estonian Republic. Increased security measures are required to guarantee public order and internal security.

These controls will be introduced at our maritime and air borders as well as at the land border with the Republic of Latvia. Border control will be limited to strictly necessary measures in order to ensure public policy and to safeguard the internal security. At our internal land border, temporary border control will be carried out at all border crossing roads and railway connections. The names of the authorised crossing-points are listed in the annex of this letter.

Additionally, widespread public communication will be used to notify people possibly affected by the reintroduction of border controls to minimize any inconvenience.
