#### **EXPLANATORY MEMORANDUM**

#### 1. CONTEXT OF THE PROPOSAL

# Reasons for and objectives of the proposal

The present proposal concerns the conclusion of the International Coffee Agreement 2022.

The International Coffee Agreement 2022 (ICA or 'the Agreement') aims to strengthen the global coffee sector and promote its economically, socially and environmentally sustainable development.

The European Union is a party to the International Coffee Agreement 2007<sup>1</sup> and a Member of the International Coffee Organization.

On 27 March 2025, the International Coffee Council, pursuant to Article 48(3) of the 2007 International Coffee Agreement, approved the extension of the ICA 2007 until 1 February 2028 and also stated the Agreement shall enter into force as soon as the conditions for its provisional or definitive entry into force are met, thus terminating the period of extension of the ICA 2007<sup>2</sup>. The Commission was authorised by Council Decision 2020/1638<sup>3</sup> to vote in favour of extensions of the ICA for periods not exceeding eight years in total beyond the original expiry date of the ICA or until the provisional or definitive entry into force of a new agreement, whichever comes first.

A partial review to reform the 2007 ICA was necessary and clearly in the interest of the Union to further align it with the practices the Union fosters in other international commodity boards, and to take developments in the global coffee market since 2007 into consideration. The new 2022 Agreement updates the balance of the voting and the contribution systems and addresses the integration of the private sector and civil society into the work of the ICO. The new Agreement takes into account the objectives of simplification and streamlining while maintaining the intergovernmental nature of the ICO. At its 133rd session on 9 June 2022 the International Coffee Council adopted the text of the new 2022 Agreement replacing the 2007 International Coffee Agreement.

The Commission negotiated the amendments that led to the new International Coffee Agreement on behalf of the Union<sup>4</sup>.

In the light of the discussions and the content of the new instrument, the Commission, having already presented the International Coffee Agreement 2022 to the Council for signature<sup>5</sup>, considers that the Agreement should be concluded and the instrument of conclusion be deposited, in accordance with Article 44(3) of the 2022 International Coffee Agreement, with the Headquarters of the International Coffee Organisation in London, designated as Depositary by the International Coffee Council Resolution 477 of 9 June 2022.

# • Consistency with existing policy provisions in the policy area

The Agreement was negotiated in line with the comprehensive negotiating directives adopted by the Council on 28 July 2021 on the recommendation from the Commission for a Council

decision authorising the opening of negotiations on a new International Coffee Agreement between the European Union and the other Members of the International Coffee Organization.

The Agreement is also fully in line with the European Green Deal<sup>6</sup>.

# • Consistency with other Union policies

The Agreement is fully in line with the Global Gateway strategy<sup>7</sup>. Indeed, the Global Gateway stands for sustainable and trusted connections that work for people and the planet. It helps to tackle the most pressing global challenges, from fighting climate change, to improving health systems, and boosting competitiveness and security of global supply chains.
