10. Joint European Union/Council of Europe declaration establishing a "European Day against the death penalty"

The proposal didn't meet the agreement of Poland whose representative underlined that the issue of the death penalty cannot be dealt without having a comprehensive debate on the right to life. He highlighted that the Polish position was not against the death penalty itself but opposing the establishment of a European day. PL expressed the view that the issue should be dealt by the JAI Council Ministers.

Many delegations (IT, SE, IE, ES, AT, DK, NL, FI, PT and the Commission) expressed serious regret towards the PL position by underlining that the lack of unanimity within the EU on such a significant issue would endanger the EU credibility and prestige in the international arena, being the well-known commitment of the Union against the death penalty. In particular, the EU initiative for a resolution before the UN was mentioned.

The Presidency concluded by asking to PL to report back to Warsaw the strong message expressed by the Committee and invited the Polish delegation to re-consider its position in order to avoid to convey a wrong signal outside.
