

Concerning the reintroduced internal border controls at the Norwegian internal borders

I refer to the letter sent by the Minister of Justice and Public security Ms. Monica Mæland on the 9<sup>th</sup> of November 2020. In the letter, she informed about the decision made by the Norwegian government to reintroduce temporary border controls at all Norwegian internal borders for 90 days from the 12<sup>th</sup> of November as a measure to combat Covid-19.

The temporary reintroduction of internal border controls is an exceptional measure of last resort. The controls have therefore so far been limited in scope to what has been considered strictly necessary to prevent the threats to internal security and pulic policy.

So far, all border crossing points on the Norwegian internal borders have remained open for travellers. However, recent developments, especially the spreading of covid-19 virus mutations, have made it necessary to further monitor and control the flow of travellers into Norway. The Norwegian government has therefore decided to reduce the number of authorised border crossing points at the Norwegian internal borders.
