**Concerning the reintroduced internal border controls at the Norwegian internal borders**

I refer to the letter sent on the 31<sup>th</sup> of December 2020 informing about the decision to reduce the number of border crossing points on the Norwegian internal border as a measure to combat Covid-19.

Recent developments, especially the spreading of covid-19 virus mutations, have made it necessary to further reduce the number of authorised border crossing points at the Norwegian internal borders.

In accordance with the Schengen Borders Code article 27, a list of authorised border crossing points for the crossing of the Norwegian internal borders is attached to this letter. The measure will enter into force on January 18<sup>nd</sup> 2021 at 17.00.
