Sweden is committed to the implementation of rules ensuring a global minimum level of taxation for multinational groups in the Union and have supported the proposed Directive when presented at previous Ecofin meetings. In order to accommodate the concerns of one Member State, a new Article 55a has been added to the Directive at a late stage. Sweden is prepared to accept the newly added Article since it is perceived necessary to reach a compromise on which there can be unanimity. However, Sweden wishes to make clear that the added language does not in any way prejudice our position of any proposal presented by the Commission based on the new Article 55a.

<p>The Netherlands, via this statement, declares it abstains from voting on the market correction mechanism, for the following reasons</p> <ul style="list-style-type: none"> <li>• Our most fundamental objection is the absence of a decent and comprehensive impact assessment before the MCM takes full effect. The implications of this mechanism are potentially severe for the financial stability of the gas market and the security of supply. Since the first draft of the proposal, the amendments have not sufficiently mitigated these risks, but actually added additional risks through the lowering of the triggering conditions and broadening of the scope.</li> <li>• Many financial institutions, experts, regulators, central banks and energy companies have warned about the potential effects on financial stability and security of supply. An impact assessment should assess and, where necessary, address these concerns.</li> <li>• As the potential effects on the TTF, and thereby the (financial) functioning of the gas market and security of supply in Northwest Europe, are too severe to ignore, we want to see an automatic suspension of the mechanism as soon as we receive signals that markets are not functioning well, for instance when the liquidity on the TTF drops below a critical level.</li> </ul> <p>Finally, the lack of additional, mandatory, obligations on saving gas and electricity is contrary to the objectives of the MCM. We still believe demand-side measures are an essential part of the toolbox to address the root cause of high prices: the disbalance between demand and supply.</p> <ul style="list-style-type: none"> <li>• The Netherlands is not accepting any liability flowing directly or indirectly from the adoption of the MCM Regulation.</li> </ul>

However, Ireland has concerns over the lack of clarity in the certain aspects of the text of the Proposal and how it interacts with other EU environmental Directives, in particular the Habitats Directive. Ireland asks the European Commission issue guidance as to how the Regulation interacts with the other EU environmental Directives, in particular the Habitats Directive, to avoid any legal issues arising in the implementation of the measures. Ireland fully supports increasing the rollout of renewable energy projects. However, Ireland is concerned that a lack of alignment with other EU environmental Directives could lead to legal challenge and uncertainty, which would have the undesired and contradictory effect of slowing down the delivery of essential renewable projects.
