Having regard to the Treaty on the Functioning of the European Union, and in particular the Article 207(4), first subparagraph, in conjunction with Article 218(9) thereof,

### Whereas:

- **(1)** The Interim Agreement on Trade between the European Union and the Republic of Chile (the 'Agreement')<sup>1</sup> was concluded by the Union by means of Council Decision (EU) 2024/3016<sup>2</sup> and entered into force on 1 February 2025.
- (2) Article 33.1(1) of the Agreement establishes a Trade Council, which, pursuant to Article 33.1(5) of the Agreement, is to establish, at its first meeting, its own rules of procedure and the rules of procedure of the Trade Committee.
- (3) The Trade Council, at its first meeting, is to adopt a decision on its rules of procedure and a decision on the rules of procedure of the Trade Committee.
- **(4)** It is appropriate to establish the position to be taken on behalf of the Union in the Trade Council, as the decision will be binding on the Union.
- (5) The position to be taken on behalf of the Union should be based on the draft Decision of the Trade Council attached to this Decision,
