

The Mission of the Principality of Liechtenstein to the European Union presents its compliments to the General Secretariat of the Council of the European Union and has the honour to refer to the notification by the Council of 25 July 2024, which reads as follows:

„In accordance with the Protocol signed between the European Union, the European Community, the Swiss Confederation and the Principality of Liechtenstein on the accession of the Principality of Liechtenstein to the Agreement between the European Union, the European Community and the Swiss Confederation on the Swiss Confederation's association with the implementation, application and development of the Schengen acquis, and with the first sentence of Article 5(2)(a) of the Protocol, the Principality of Liechtenstein is herewith notified of the adoption of the following act:

**Regulation of the European Parliament and of the Council amending Regulation (EU) 2018/1806 as regards holders of Serbian passports issued by Serbian Coordination Directorate (Kordinaciona uprava)**

Date of adoption: 22 July 2024”
