Subject:	Draft DIRECTIVE OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL on Soil Monitoring and Resilience (Soil Monitoring Law) (first reading)
	 Adoption of the Council's position at first reading and of the statement of the Council's reasons

- 1. On 5 July 2023, the <u>Commission</u> submitted its proposal¹, based on Article 192(1) TFEU, to the Council.
- 2. The <u>European Economic and Social Committee</u> delivered its opinion on 25 October 2023².
- 3. The Committee of the Regions delivered its opinion on 19 June 2024³.
- 4. The European Parliament adopted its position at first reading on 10 April 2024⁴.

- 5. The <u>Permanent Representatives Committee</u> confirmed on 21 May 2025 the provisional agreement reached by the co-legislators on the above Directive⁵, after informal contacts had taken place between the Council and the European Parliament.
- 6. On 5 June 2025, the <u>European Parliament's Committee on Environment, Climate and Food Safety</u> (ENVI) confirmed the provisional agreement reached by the co-legislators on the above Directive. Subsequently, its Chair sent a letter to the Chair of the Permanent Representatives Committee stating that the European Parliament should, at its second reading, approve the Council's position at first reading (following a legal-linguistic revision) without amendments⁶.
- 7. The <u>Permanent Representatives Committee</u> is asked to suggest that the <u>Council adopt its</u> position at first reading, as set out in 9474/25 + COR 1, and the statement of reasons, as set out in 9474/25 ADD 1, as an 'A' item at a forthcoming meeting, with <u>Germany</u> voting against and <u>Austria</u> abstaining.
- 8. The statements for the minutes of the Council are set out in the <u>Addendum</u> to this note.
