EXPLANATORY MEMORANDUM

1. CONTEXT OF THE PROPOSAL

- **Reasons for and objectives of the proposal**

Council Regulation (EU) 2023/2720¹ opening and providing for the management of autonomous Union tariff quotas (ATQs) for certain fishery products for the period 2024-2026 was adopted on 27 November 2023.

The objective of the Regulation is to ensure the competitiveness of the Union processing industry and avoid jeopardising Union production of fishery products by guaranteeing an adequate supply of fishery products to the industry. To this end, the Regulation reduces or suspends import duties for a number of fishery products within tariff quotas of an appropriate volume. It also defines which processing operations ('qualifying operations') allow the use of the tariff quotas and which do not.

This Commission proposal seeks to extend by one year the validity of the current ATQ Regulation, to ensure continuity and predictability of the current ATQ regime while the Commission is finalising its work on a back-to-back evaluation and impact assessment on the introduction of sustainability criteria into the ATQ regime. These new criteria will accompany the Commission proposal on the introduction of sustainability criteria (planned for adoption in the first quarter of 2027).

The proposed one-year extension reflects the need for additional time to ensure an appropriate transition towards any future framework.

- **Consistency with existing policy provisions in the policy area**

The proposal is consistent with the EU's policy of securing an adequate supply of fishery products for its processing industry. The ATQ regime is a long-standing instrument within the EU's trade and fisheries policy framework. It enables the suspension or reduction of import duties on specific fishery products to facilitate access for the EU's processing industry to raw materials and semi-finished products that are not available in the EU in sufficient quantities.

- **Consistency with other Union policies**

The proposal is consistent with the EU policy on autonomous quotas that enables the suspension or reduction of import duties on specific fishery products to facilitate access for the EU's processing industry to raw materials and semi-finished products that are not available in the EU in sufficient quantities.

2. LEGAL BASIS, SUBSIDIARITY AND PROPORTIONALITY

- **Legal basis**

Article 31 TFEU – Common Customs Tariff.

- **Subsidiarity (for non-exclusive competence)**

Common customs tariff duties fall under the exclusive competence of the Union. The subsidiarity principle therefore does not apply to these provisions.

- **Proportionality**

The proposal is proportionate because for each product only a quota volume is allowed to be exempted from customs duties, within a limited period. It is suitable for achieving the objective of duty-free supply of fisheries raw materials to the EU market (seafood processors and EU consumers). It does not go beyond what is necessary to achieve the objectives.

- **Choice of the instrument**

Council Regulation is proposed so to amend the existing Council Regulation (EU) 2023/2720.

3. RESULTS OF EX-POST EVALUATIONS, STAKEHOLDER CONSULTATIONS AND IMPACT ASSESSMENTS

- **Ex-post evaluations/fitness checks of existing legislation**

- **Stakeholder consultations**

No stakeholder consultation has been carried out. The proposal maintains the status quo of the current Regulation, which was subject to an extensive stakeholder consultation in 2023.

- **Collection and use of expertise**

Not applicable.

- **Impact assessment**

The proposal amends the period of validity of the current Regulation that expires at the end of 2026, therefore there is no need for an impact assessment. However, in view of establishing sustainability criteria which would be applicable to fishery products import to the Union, an impact assessment is currently being carried out on the possible introduction of such criteria into the autonomous preferences for certain fishery products.

- **Regulatory fitness and simplification**

4. BUDGETARY IMPLICATIONS

The proposal does not have a budgetary impact for the Commission. However, the proposal has a budgetary impact on the EU revenue in terms of loss of customs duties which would have been collected on imported products as explained in the legislative financial statement.

- **Detailed explanation of the specific provisions of the proposal**

The proposal amends the period of validity of Council Regulation (EU) 2023/2720 and extends the validity of the quotas laid down in this Regulation until 31 December 2027, the time necessary to finalise the impact assessment of the ATQ regime and to adopt a new proposal including sustainability requirements.

(Text with EEA relevance)

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 31 thereof,

Having regard to the proposal from the European Commission,

Whereas:

- (1) Council Regulation (EU) 2023/2720² opens and provides for the management of autonomous Union tariff quotas (ATQ) for certain fishery products for the period 2024-2026. That Regulation reduces or suspends import duties for a number of fishery products within tariff quotas of an appropriate volume. Appropriate volumes have been decided for each tariff quota to ensure an adequate supply to the Union industry for this period. The Regulation also defines which processing operations allow the use of the tariff quotas.
- (2) The proposal for a new ATQ Regulation for the application of the autonomous tariff preferences for the next period is still in the process of finalisation due to the incorporation of sustainability conditions aiming at reflecting the sustainability commitments of the European Union in the ATQ regime.
- (3) To avoid the gap in the provision of duty-free supplies of fisheries products to the European Union, it is necessary to extend the validity of the current Regulation until the end of 2027, the time necessary for the adoption of the new proposal.

HAS ADOPTED THIS REGULATION:

Article 1

Article 6 of Regulation (EU) 2023/2720 is amended as follows:

“Article 6

This Regulation shall enter into force on the twentieth day following that of its publication in the Official Journal of the European Union.

It shall apply from 1 January 2024 to 31 December 2027.

This Regulation shall be binding in its entirety and directly applicable in all Member States”

Article 2

The Annex to Regulation (EU) 2023/2720 is amended as follows:

In the column ‘quota period’ of the table in the Annex to Regulation (EU) 2023/2720, all the quota validity periods ‘1.1.2024–31.12.2026’ are replaced by the quota validity periods: ‘1.1.2024–31.12.2027’.

Article 3

This Regulation shall enter into force on the day following that of its publication in the *Official Journal of the European Union*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

1. FRAMEWORK OF THE PROPOSAL/INITIATIVE

1.1. Title of the proposal/initiative

Proposal for a Council Regulation opening and providing for the management of autonomous Union tariff quotas for certain fishery products for the period 1 January – 31 December 2027.

1.2. Policy area(s) concerned

EU trade and fisheries policies.

1.3. Objective(s)

1.3.1. General objective(s)

The general objective of the ATQ regime is to address a structural trade deficit in the EU aquatic food market and support the competitiveness of the EU processing sector.

1.3.2. Specific objective(s)

- Improving the accessibility and availability of raw materials and or semi-finished goods that are not available through EU production (fishing or aquaculture) in sufficient quantities and/or at a competitive price; and
- Ensuring that ATQs are adapted to market conditions (for example, structural gap between EU demand and limits of EU production, and changes in trade flows) and the needs of EU seafood processors (for example, growing demand for a specific product), without adversely impacting EU producers.

1.3.3. Expected result(s) and impact

Specify the effects which the proposal/initiative should have on the beneficiaries/groups targeted.

The expected result of the ATQ regime in terms of outputs is a list of raw materials and their volume for which custom duties are exempted partially or totally, that are consistent with the need of the EU processing sector. In the medium to long-term, the ATQ regime is expected to improve competitiveness of EU aquatic food processors, without adversely impacting EU producers.

1.3.4. Indicators of performance

Specify the indicators for monitoring progress and achievements.

EU processing industry's access to raw materials and semi-finished goods is maintained or improved in terms of volume and price as over the period 2024-2026. The ATQ regime has remained responsive to evolving market conditions and stakeholders' needs throughout 2027.

1.5. Grounds for the proposal/initiative

The proposal extends the validity of the autonomous tariff quotas laid down in the Council Regulation (EU) 2023/2720 until 31 December 2027.

1.5.2. Added value of EU involvement (it may result from different factors, e.g. coordination gains, legal certainty, greater effectiveness or complementarities). For the purposes of this section 'added value of EU involvement' is the value resulting from EU action, that is additional to the value that would have been otherwise created by Member States alone.

The ATQ regime provides clear EU added value because its objectives cannot be achieved by Member States acting individually. Under Article 3(1)(a) TFEU, the customs union is an area of exclusive EU competence, meaning that Member States cannot set national customs duties, tariff suspensions, or autonomous quotas.

ATQ regime ensures uniform access conditions for raw materials across the single market, avoids competitive distortions that would arise from divergent national approaches, and provides predictable tariff conditions for EU processors.

1.5.3. Lessons learned from similar experiences in the past

Past experiences on the ATQ regime's implementation demonstrate that the regime is relevant for addressing structural economic needs in the EU aquatic food sector, including from an employment perspective. The EU is a long-standing net importer of aquatic food, and ATQs facilitate access and availability of raw materials for processors. The number of quota requests and species covered has evolved over time, in line with evolving market needs.

The main impact of the Regulation is the loss of revenue for the European Union. Taking the most recent complete statistics (2021-2022) as a basis, the impact on the loss of revenue resulting from this Regulation may be estimated at €272,04 million for 2027.

The stated amount has been calculated on the basis of MFN duty rates, full utilisation of quotas, average price (€) per ton and the fact that 80% of the duties are included in the EU budget. It marks, therefore, the maximum level of loss of revenue since the Union grants more favourable trade preferences to different groups of third countries (GSP, GSP+, FTAs).

Therefore, the actual loss of revenue tends to result in a lower amount since MFN duties do not apply across the board and the quotas laid down in the Regulation are not fully used.

Checks on the end-use of some of the products covered by this Council Regulation are carried out in accordance with Article 254 of Regulation (EU) No 952/2013 laying down provisions for the implementation of the Community Customs Code.
