against serious human rights violations and abuses**

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on European Union, and in particular Article 29 thereof,

Having regard to the proposal from the High Representative of the Union for Foreign Affairs and  
Security Policy,

Whereas:

- (1) On 7 December 2020, the Council adopted Decision (CFSP) 2020/1999<sup>1</sup>.
- (2) On 8 December 2020, by way of the Declaration by the High Representative of the Union for Foreign Affairs and Security Policy, on behalf of the European Union, regarding the EU Global Human Rights Sanctions Regime, the Union and its Member States reaffirmed their strong commitment to the promotion and protection of human rights around the world. The EU Global Human Rights Sanctions Regime underscores the Union's determination to enhance its role in addressing serious human rights violations and abuses worldwide. Achieving the effective enjoyment of human rights by everyone is a strategic goal of the Union. Respect for human dignity, freedom, democracy, equality, the rule of law and human rights is a fundamental value of the Union and its common foreign and security policy.
- (3) In its conclusions of 19 March 2026, the European Council strongly condemned the continued and growing settler violence against Palestinian civilians and again reiterated its call on the Council to take work forward on further restrictive measures against extremist settlers and against entities and organisations that support them.

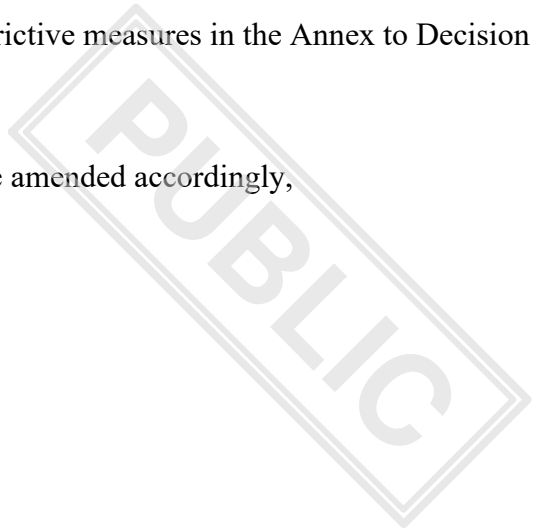

(5) Decision (CFSP) 2020/1999 should therefore be amended accordingly,
