"It is important to Denmark that the Commission should commit itself to proposing - as soon as possible - appropriate measures to ensure that the environmental advantages stemming from set - aside would be retained in another manner."

"The Slovak Republic is aware of the difficulties with the implementation of the above proposal, neverthless it accepts the Regulation on the passengers' rights as a matter of a political will.

However, the Slovak Republic would like to point out a very broad definition of the persons with reduced mobility in Article 3 paragraph 15 of the draft Regulation which may cause difficulties when implementing this Regulation. There is a reference in several articles of the Regulation to technical specification of interoperability (TSI) which should define precisely the persons with reduced mobility. TSI are specified under comitology procedure by the Commission assisted by the Committee for Interoperability. In our opinion, TSI for persons with reduced mobility, as they drafted under comitology procedure at the moment, are not drafted consistently with the definition in the Regulation.

Therefore, the Slovak Republic invites the Commission to remove this inconsistency in order to ensure a proper implementation of the Regulation."

The Chairman noted a very large qualified majority in favour of the adoption of the proposal. The Chairman, however, noted that FR, supported by DE, IT and PL, expressed the wish to further discuss the issue in the Agriculture and Fisheries Council. Moreover the Chairman noted the agreement of <u>the Committee</u> to the Commission's technical amendment to Article 2 concerning the notification procedure.

The Chairman concluded that while the item will be submitted to the Council for adoption as an "A" Item in accordance with the deadlines established in the Council rules of procedure, the Agriculture and Fisheries Council on 26-27 September 2007 could be invited to discuss the issue.
