The SCA took note of the information provided by the Presidency and of the comments of the Commission and of delegations as well as their responses to the questions. It thus prepared the item for the Council meeting on 28 and 29 September 2026.

It also took note of delegations' replies to the Presidency's guiding questions concerning certain outstanding issues.

4. **Drought conditions**
Exchange of views

The SCA exchanged views based on two guiding questions from the Presidency on how best to address the consequences of the drought conditions facing farmers and stressed the importance of providing the right EU support and flexibilities, thereby contributing to the preparation of the "Agriculture and Fisheries" Council meeting on 28 29 September 2026.

The SCA agreed on the EU position to take at the 24th OIV General Assembly.

As regards the resolutions with legal effects, it agreed to invite the Council to adopt the Decision, as set out in document 11099/1/26 REV 1, as an “A” item after legal/linguistic finalisation.

As regards the resolutions without legal effects, it approved the position that the Commission had proposed, with the exception of the draft resolution SECSAN CONUSA 23-743, which should remain at the technical level.

The SCA took note of the information provided by the Commission on the new strategy for the EU outermost regions and the proposed legislative changes. It also took note of delegations’ comments.

Regarding the “Agriculture and Fisheries” Council meeting on 28-29 September 2026:

- Austria requested a public item under “any other business”, on “the impact of the ongoing drought on Austrian and European agriculture”;
- Croatia requested a public item under “any other business”, on the meeting of Agriculture Ministers of MED9, held in Zadar, Croatia, on 5–7 July 2026.
- The SCA agreed these two AOB items would be taken in public session in accordance with Article 8(2) of the rules of procedure of the Council.
