**REPORT FROM THE COMMISSION TO THE EUROPEAN PARLIAMENT AND
THE COUNCIL**

**on the exercise of the power to adopt delegated acts pursuant to Regulation (EU)
2017/1004 concerning
Union framework for the collection, management and use of data in the fisheries sector**

1. INTRODUCTION

Regulation (EU) 2017/1004 of the European Parliament and of the Council¹ establishes a Union framework for the collection, management and use of data in the fisheries sector and support for scientific advice regarding the common fisheries policy. It confers on the Commission the power to adopt delegated acts.

Article 4(1) of that Regulation empowers the Commission to adopt delegated acts to establish the detailed list of data requirements to achieve the objectives set out in Articles 2 and 25 of Regulation (EU) No 1380/2013 of the European Parliament and of the Council on the common fisheries policy², which forms part of the multiannual programme³.

2. LEGAL BASIS

According to Article 24(2) of Regulation (EU) 2017/1004, the delegation to the Commission is conferred for a period of 3 years, starting from 10 July 2017. The delegation of power is tacitly extended for periods of 3 years, unless the European Parliament or the Council oppose such extension no later than 3 months before the end of each period.

In accordance with Article 24(2), the Commission is required to draw up a report in respect of the delegation of power no later than 9 months before the expiry of the duration of the empowerment. This report fulfils that obligation.

3. EXERCISE OF DELEGATION

The Commission did not use its delegated power in last three years 2022-2024, because Commission Delegated Decision (EU) 2021/1167⁴ of 27 April 2021 establishing the multiannual Union programme for the collection and management of biological, environmental, technical and socio-economic data in the fisheries and aquaculture sectors from 2022 is still in force and can accommodate evolving requirements thanks to its non-exhaustive character.

Although the multiannual programme does not contain an end date on which that programme will cease to apply or be valid, it may be revised in a foreseeable future to accommodate emerging needs for data, and to adapt its scope to changing fisheries profiles and policy requirements, in accordance with Better Regulation principles.
