- 1. On 11 June 2013 and on 22 September 2020 the <u>Commission</u> submitted its proposals<sup>1</sup>, based on Article 100(2) TFEU, to the Council.
- 2. The <u>European Economic and Social Committee</u> delivered its opinions on 11 December 2013 and on 2 December 2020<sup>2</sup>.
- 3. The <u>Committee of the Regions</u> was consulted and decided not to issue an opinion.
- 4. The <u>European Parliament</u> adopted its position at first reading on 12 March 2014<sup>3</sup>.

- 5. The Permanent Representatives Committee confirmed on 22 March 2024 the provisional agreement reached by the co-legislators<sup>4</sup>, after informal contacts had taken place between the Council and the European Parliament.
- On 9 April 2024, the European Parliament's Committee on Transport and Tourism (TRAN) 6. confirmed the provisional agreement, and its Chair subsequently sent a letter to the Chair of the Permanent Representatives Committee declaring that the European Parliament should, at its second reading, approve the Council's position at first reading (following a legal-linguistic revision) without amendments.
- 7. The <u>Permanent Representatives Committee</u> is asked to suggest that the <u>Council</u>:
  - adopt its position at first reading, as set out in 8311/24 + COR 1, and the statement of reasons, as set out in 8311/24 ADD 1 + COR 1, as an 'A' item at a forthcoming meeting, with **Spain** abstaining;
  - approve the joint statement by the Council and the European Parliament, as set out in Addendum 1 to this note.
- 8. The statements for the minutes of the Council meeting are set out in the Addenda 1 and 2 to this note.
