Having regard to Council Regulation (EC) No 2062/94 of 18 July 1994 establishing a European Agency for Safety and Health at Work<sup>1</sup>, and in particular Article 8 thereof,

#### Whereas:

- In its Decisions of 17 October 2016<sup>2</sup>, of 28 November 2016<sup>3</sup>, and of 23 January 2017<sup>4</sup> the **(1)** Council appointed the members and alternate members of the Governing Board of the European Agency for Safety and Health at Work for the period ending on 7 November 2019.
- A seat as member in the governments' representatives category has fallen vacant as a result of (2) the resignation of Mr Javier MAESTRO ACOSTA.
- (3) The government of Spain has nominated a candidate for the vacant seat,
