"The Council and the Commission confirm the agreement reached at the close of the proceedings of the Working Party on Fiscal Questions on 27 September 2000 on the main points of the draft Directive on mutual assistance on recovery as contained in 11950/00 ADD 1 FISC 140. The Council and the Commission also note that this agreement depends on a satisfactory solution to the question of the legal basis for the draft Directive.

<u>The Council</u> calls on COREPER to complete its discussions on this draft Directive, and especially on its legal basis, so that it can be adopted as soon as possible."
