STATEMENT 233/99

Statement by the Commission

"The Commission undertakes to assist Member States in the timely application of this Regulation, in particular Article 4(2)(d). To this end, it will call upon experts in Member States to provide relevant guidelines on practical and comparable methods of implementation."

STATEMENT 234/99

Statement by the Austrian delegation

"This is an index segment where predominantly non-market prices are to be dealt with (in the National Accounts: "economically non-significant prices", i.e. provision of health, education and social protection products). There are specific difficulties involved in this kind of price observation, which are most striking in the case of income dependent pricing but are similarly present in other variants of such price formation, too. Notoriously, there are significant differences between market prices and those of the non-market sector within countries as well as between the various countries with respect to non-market price formation itself. While from the point of consumers (private households) these difficulties may not matter so much, it is indispensable to pay attention to them to ensure adequate analysis and interpretation. This issue will therefore have to be explicitly addressed in the reports to be submitted by the Commission to the Council."

STATEMENT 235/99

Statement by the Italian delegation

"In this Regulation, notably in Article 4(2), a principle is to be adopted without any appraisal of the most suitable methodology for applying it or of its practical implications.

The application of this principle would mean, within a single country, using non-uniform criteria for calculating the various items included in the basket, and the lack of clear guidance as to methodology would severely detract from the index's comparability between Member States, rendering it less meaningful. We would also point out that to apply this principle in practice requires data for which consolidated statistical sources are not available.

On account of these problems, Italy opposes the adoption of the principle set out in Article 4(2) of the Regulation and requests more detail with regard to implementing the Regulation in order to improve the comparability of the indices of the various Member States."

STATEMENT 236/99

"The Commission and the Council state that any exceptional case which may lead to an authorisation of a Member State to apply the reduced rate to services in three of the categories mentioned in Annex K includes in particular the case where the economic weight of the services concerned is of little importance."

STATEMENT 237/99

"The Commission and the Council state that this Directive has no influence on the transitional provisions of Article 28 of the sixth VAT Directive, which allow some Member States to continue to apply reduced rates to certain supplies of goods or services."

STATEMENT 238/99

"<u>The Commission</u> undertakes to examine positively a request from Portugal to apply a reduced VAT rate on restaurant services. The Council agrees to this in the belief that it allows Portugal to continue existing practice."

STATEMENT 239/99

"The Commission undertakes to transmit without delay to the Member States the German application pursuant to Article 27 of the Sixth Directive to be allowed to introduce a measure for derogation from Article 6(2) and Article 17 of the Sixth Directive (limitation of the right to deduct input tax) and to submit to the Council a relevant proposal for a Decision so that the Council may decide upon it at the same time as it decides upon the requests for authorisations presented under this Directive."

STATEMENT 240/99

"The Commission undertakes to examine positively a request from Austria for a prolongation of the derogation accorded under the Accession Treaty to apply a reduced rate to the letting of immovable property for residential use and to submit it to the Council as soon as possible so that the Council may decide upon it at the same time as it decides upon the requests for authorisations presented under this Directive."

STATEMENT 241/99

"The German delegation agrees to the Directive in the expectation that it will be applied in a restrictive manner."

Belgian delegation's explanation of its vote		
Belgium cannot agree to the draft Directive submitted for the Council's approval.		
It considers the Directive detrimental to quality chocolate.		
The harmonisation of the use of vegetable fats has made what was <u>a</u> <u>derogation</u> accorded to a few Member States into <u>a general rule.</u>		
Belgium does not see this Directive as contributing to the process of legislative simplification but as making fundamental changes in the composition of chocolate products.

The Belgian delegation deplores the fact that there has been <u>no serious</u> study of this Directive's impact on cocoa-producing countries, in particular the ACP States, the European Community's long-standing contractual cooperation partners.	
Belgium cannot endorse a Directive which seeks to harmonise conditions for producing and marketing chocolate but at the same time continues to apply an <u>exception</u> regarding sales names for <u>two countries</u> . This is pick-and-choose harmonisation that accommodates only some Member States' industries.	
The lack of a <u>reliable method of analysis</u> coupled with the fact that not all chocolate products are covered by the vegetable fat provisions will tend to <u>mislead consumers</u> . The proposed labelling provisions do not ensure that consumers are fully and clearly informed.	
For all these reasons Belgium continues to believe that this is not a good draft Directive.	
Explanation of vote by the French delegation	
France continues to attach particular importance to the quality of chocolate. It feels that harmonisation must at all costs protect the legitimate interests of consumers and of the ACP cocoa-producing countries.	
It acknowledges the merits of the compromise worked out by the Presidency, which has achieved a degree of balance between national positions which were originally very divergent. France supports the compromise, but would emphasise that it will remain especially vigilant on a number of essential points: validation by the Commission of a reference method for quantifying vegetable fats other than cocoa butter before the Directive enters into force; detailed impact study to be carried out by the Commission in the light of experience acquired and before any revision of the positive list of those vegetable fats; effective implementation of the labelling requirements.	
France also feels that, as the subject is so sensitive, future adjustments of the substantive technical provisions of the Directive should remain a matter for the legislator.
