5. Stocktaking of the second year of implementation of the CAP strategic plans

Information from the Presidency Preparation of the Council debate

In preparation for the "Agriculture and Fisheries" Council of 23 September 2024, <u>the SCA</u> endorsed the two questions regarding the stocktaking of the second year of implementation of the CAP Strategic Plans suggested in the Presidency's background document (13124/24). It took note of delegations' and the Commission's preliminary answers to the questions.

<u>The SCA</u> agreed to hold the ministerial debate in public session, in accordance with Article 8(2) of the Council's Rules of Procedure.

<u>The SCA</u> took note of the information provided by the Presidency on the organisation of the Council debate, of the information provided by the Commission on the situation of agricultural markets, including the beef and veal, sheep meat and goat meat sectors¹, and of delegations' comments and questions.

8. Organisation of future work

<u>The Presidency</u> informed the SCA about the "Agriculture and Fisheries" Council meeting on 23 September 2024 and the next SCA meeting on 30 September.

Regarding that Council meeting,

- <u>Belgium</u> requested a public item under "any other business", on the "Challenges and consequences of the spread of the bluetongue virus the need for a rapid response";
- <u>Italy</u> requested a public item under "any other business", on the "Rice imported from EBA Countries as a subject of an automatic safeguard measure in the GSP Regulation";
- <u>Latvia</u> requested a public item under "any other business", on "The Common Agricultural Policy (CAP) and performance of the New Delivery Model";
- <u>Lithuania</u> requested a public item under "any other business", on "The use of EAFRD-funded investments"; and
- <u>Bulgaria</u> requested a public item under "any other business", on the "Protective measures according to Art. 4(1) of Regulation (EU) 2024/1392 and in particular prohibiting the import of eggs originating from Ukraine".

<u>The SCA</u> agreed that these AOB items would be taken in public session in accordance with Article 8(2) of the rules of procedure of the Council.

In addition, <u>Greece</u> informed the SCA about a public item under "any other business", on "sheep and goat plague", requested at COREPER on 6 September.
