Statement by Belgium

"Belgium welcomes the signing of the Investment Protection Agreement between the European Union and its Member States, of the one part, and the Republic of Singapore, of the other part.

Belgium reaffirms its commitment to the ongoing reform of investment dispute resolution. It constitutes a step towards the establishment of a multilateral investment court which shall become the responsible legal institution to resolve conflicts between investors and states. Belgium continues to support the Commission's ongoing efforts in this regard.

Belgium reiterates the importance of the statement of the Commission and the Council on investment protection and the Investment Court System (ICS), included in Council document 13463/1/16 REV 1 of 27 October 2016. In this context, Belgium welcomes the important progress which has been achieved in implementing this declaration through the inclusion, in the Investment Protection Agreement with Singapore, of rules on transparency, an appeal mechanism ensuring the consistency of decisions as well as some important innovations, notably the process for selecting all judges of the Tribunal and the Appeal Tribunal, their remuneration by the parties on a permanent basis and the code of conduct for members of the Tribunal, the Appeal Tribunal and Mediators.

Belgium believes that the opinion of the Court of Justice of the EU on the compatibility of ICS with EU treaties (Opinion 1/17) will contribute to further clarify the legal framework in which ICS can be established. Belgium takes note that the provisions of the Investment Protection Agreement with Singapore shall only enter into force when all Member States have ratified the Agreement in accordance with their national constitutional procedures. Belgium welcomes that the Commission does not propose the provisional application of this Agreement and that it will not be concluded before the CJEU renders its Opinion 1/17.

As already expressed in the statement of the Kingdom of Belgium on the conditions attached to full powers for the signing of CETA, included in Council document 13463/1/16 REV 1 of 27 October 2016, it will ultimately be the responsibility of the respective parliaments of the Kingdom of Belgium to ratify the Investment Protection Agreement with Singapore as it stands on the day on which it is signed and on the basis of, inter alia, the system for resolving disputes between investors and States as set out in the Agreement. Belgium wishes to make clear that, in accordance with its constitutional law, the result of the consent procedures undertaken both in the Federal Parliament and in each of the parliamentary assemblies of the competent federated entities may be that the process of ratifying the Investment Protection Agreement has permanently and definitively failed.

Belgium underlines that this agreement reaffirms the parties' right to regulate within their territories to achieve legitimate policy objectives, such as the protection of public health, social services, public education, safety, environment or public morals, social or consumer protection, privacy and data protection, and the promotion and protection of cultural diversity. Belgium has taken note that national treatment shall not apply to audio-visual services."

Statement by the Commission

"The Commission recalls that it has not proposed and does not intend to propose the provisional application of the agreement. The Commission understands that, in accordance with well-established practice, the Council will refrain from approving the conclusion of the agreement before the Court renders its opinion in the Opinion 1/17. If necessary in light of that Opinion, the Commission will make appropriate proposals before the Council approves the conclusion of the agreement."

Statement by Greece

"Greece fully acknowledges the importance of EU – Singapore Free Trade Agreement (FTA) and Investment Protection Agreement, as important steps towards deepening the EU-ASEAN trade and investment relations.

Greece recalls that the FTA itself does not offer direct protection of EU GIs and that Singapore has to run the official opposition procedures for the 196 EU GIs, which are included in the Annex to the Intellectual Property chapter, in order to confirm the final list. Greece notes that a satisfactory outcome for the protection of EU geographical indications in Singapore prior to the conclusion and entry into force of the Agreement is a prerequisite for a mutually beneficial Agreement. Particularly regarding PDO “Feta”, Greece considers necessary that it will be granted full protection as for other EU GIs of high economic importance.

Greece highlights that the protection of EU geographical indications substantially contribute to regional development and employment. Greece also recalls the Commission's commitments on the occasion of CETA and SADC Agreements namely: a) to achieve the best possible level of protection of all EU registered geographical indications, including PDO “Feta”, under ongoing or future negotiations of trade Agreements with third countries and b) to take all necessary measures to protect the PDO “Feta” not only within EU, but also in third –countries’ markets as regards all possible unfair practices, which led to consumer misinformation. Furthermore, Greece welcomes the assurances of Commissioner Malmström as set out in her letter of the 1st of June 2018 that the Commission remains confident that PDO “Feta”, like all other EU high-value GIs, will be protected in Singapore in line with the terms of protection laid down in the FTA.

Taking into account the aforementioned, Greece gives its consent as regards the Council Decision on the signing, on behalf of the EU, of the FTA between the EU and the Republic of Singapore and states its expectation that PDO “Feta” will be registered as a geographical indication in Singapore with exclusive rights. Greece reserves its position as regards the adoption of the Council Decision on the conclusion EU-Singapore FTA Agreement, which will be conditional upon the outcome as regards the level of protection of the PDO “Feta” in the Singaporean market."

Statement by Italy

"Italy acknowledges the importance of the EU –Singapore Free Trade Agreement, in the framework of the strategic EU-ASEAN trade and investment relations. FTAs offer a crucial instrument to ensure reciprocal and mutually beneficial market access, as well as to enhance global governance on issues like working conditions, food safety, public health and environmental protection. Also, FTAs represent an essential legal instrument to the international protection of geographical indications, which encompasses multilateral (Lisbon Agreement and the Geneva Act) and bilateral agreements.

In that respect, from the Italian perspective, the EU – Singapore Free Trade Agreement (FTA) holds a key relevance in defending geographical indications as intellectual property right and also as part of cultural heritage of Italy and EU.

In this regard, Italy wishes to recall that the FTA with Singapore does not offer direct protection of the 196 EU GIs included in the Annex to the Intellectual Property chapter and that the EU GIs will need to be examined and pass through an opposition period, according to the registration procedure in Singapore, in order to be protected. This registration procedure could be applied only once the implementing legislation on GIs will be adopted and the Singaporean registry for GIs be put in place, following the consent of the European Parliament to the conclusion of the FTA. Only at the end of this procedure, the Singaporean Authorities will be able to confirm the final list, with no certainty about the registration or the rejection of each listed GI.

Italy wishes to remind that Singapore Authorities have pledged to ensure the timeliness of the administrative procedure and to verify the generic nature when it is asserted in the opposition, taking on other commitments to reassure the European side. After informal public consultation by Singapore, a list of names probably subject to oppositions have already been communicated, including the PDO Fontina.

In this framework, Italy emphasizes that a satisfactory outcome for the effective protection of all EU GIs in Singapore prior to the conclusion and entry into force of the Agreement is a prerequisite for a mutually beneficial Agreement.

Italy therefore invites the Commission to continue to work intensively with the Singaporean Authorities in order to ensure that all EU GIs will be protected in line with the terms of protection laid down in the FTA.

Taking into account the aforementioned, Italy gives its consent as regards the Council Decision on the signing, on behalf of the EU, of the FTA between the EU and the Republic of Singapore and states its expectation that all GIs, will be registered as a geographical indication in Singapore with exclusive rights, without any exception or limitation (including annexes of footnotes), in order to preserve of both legitimate GI producers and consumers.

Italy reserves its position as regards the adoption of the Council Decision on the conclusion EU-Singapore FTA Agreement, which will be conditional upon the successful result for registration and full protection of the listed Italian GIs, via the aforementioned FTA in the Singaporean territory."

Statement by Ireland

"Should the implementation of the Agreement by the European Union necessitate a recourse to measures pursuant to Title V of Part Three of the Treaty on the Functioning of the European Union, the provisions of the Protocol on the position of the United Kingdom and Ireland in respect of the area of freedom, security and justice, annexed to the Treaty on European Union and the Treaty on the functioning of the European Union, will be fully respected."
