Subject:	Transfer of appropriations No DEC 21/2022 within Section III - Commission - of the general budget for 2022

---

1. On 7 October 2022, the Commission submitted to the Council proposal for transfer of appropriations No DEC 21/2022, in accordance with Article 31(1) of the Financial Regulation<sup>1</sup>.

The purpose of this proposal is to reallocate a total amount of EUR 10.7 million in non-differentiated appropriations from Items 20 02 06 01 (*Mission and representation expenses*), 20 02 06 02 (*Meetings, expert groups and conference's expenses*) and 20 02 06 03 (*Meetings of committees*) to Items 20 01 02 01 (*Remuneration and allowances -- Headquarters and Representation offices*), 20 03 12 01 (*Technical equipment and services for the Commission conference rooms*) and 20 03 13 01 (*Translation expenditure*), as set out in document 13320/22.

2. The transfer is being proposed in order to:
  - cover part of the expected salary update for 2022 (EUR 4.3 million), in addition to the amount requested in draft amending budget No 5/2022 (EUR 11.7 million)<sup>1</sup>;
  - renovate the Commission's meeting spaces (EUR 4.4 million);
  - cover the expenditure until the end of the year for outsourcing of translation (EUR 2.0 million).
3. The Budget Committee examined the proposal for a transfer at its meeting on 11 October 2022.
4. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
  - the proposed transfer of appropriations, as set out in document 13320/22; and
  - the draft letter in the ANNEX to this note.
