Having regard to the Treaty on European Union, and in particular the third paragraph of Article 38 thereof,

Having regard to Council Decision 2010/452/CFSP of 12 August 2010 on the European Union Monitoring Mission in Georgia, EUMM Georgia¹, and in particular Article 10(1) thereof,

Whereas:

- (1) Pursuant to Decision 2010/452/CFSP, the Political and Security Committee (PSC) is authorised, in accordance with the third paragraph of Article 38 of the Treaty, to take the relevant decisions for the purpose of exercising the political control and strategic direction of the European Union Monitoring Mission in Georgia (EUMM Georgia), including the decision to appoint a Head of Mission.
- On 11 February 2020, the PSC adopted Decision (CFSP) 2020/200¹ appointing Mr Marek SZCZYGIEŁ as Head of Mission of EUMM Georgia from 15 March 2020 to 14 December 2020.
- (3) On 3 December 2020, the Council adopted Decision (CFSP) 2020/1990² extending the mandate of EUMM Georgia to 14 December 2022.
