Subject: European Semester 2026
- Updated roadmap

Delegations will find attached the updated European Semester roadmap, as prepared by the Presidency and the incoming Presidency.

The Presidency and the incoming Presidency have prepared this updated roadmap to outline the key steps of the 2026 European Semester cycle.

The objective of the roadmap is to ensure that all relevant Council configurations, and their preparatory bodies, work in a coordinated and consistent manner towards a thorough preparation of the European Council discussions on the European Semester and to enable COREPER and the General Affairs Council to oversee the process.
