d) Detailed grounds for the decrease

Article 9 of Council Regulation (EU, EURATOM) No 2020/2093 of 17 December 2020 laying down the multiannual financial framework for the years 2021-2027 allows the Solidarity and Emergency Aid Reserve (SEAR) to finance the assistance under the European Union Solidarity Fund.

Point 10 of the Interinstitutional Agreement of 16 December 2020 between the European Parliament, the Council of the European Union and the European Commission on budgetary discipline, on cooperation on budgetary matters and on sound financial management, as well as on new own resources, including a roadmap towards the introduction of new own resources (IIA), lays down the modalities for the mobilisation of the European Union Solidarity Fund (EUSF) in the context of the SEAR.

d) Detailed grounds for the increase

The transfer of EUR 668,5 million is necessary in order to cover the commitment and payment needs arising from the Commission proposal to make a financial contribution from the EUSF available for the applications in response to natural disasters occurred in 2021 and presented by Germany, Belgium, the Netherlands, Austria and Luxembourg (floods), as well as Spain (volcano eruption in La Palma) and Greece (Crete earthquake).

The total amount of the EUSF support for the above mentioned Member States is EUR 718,5 million, of which EUR 668,5 million will be covered by the proposed transfer. An amount of EUR 50 million will be covered by using the appropriations inscribed in the general budget in accordance with Article 4a of Council Regulation (EC) No 2012/2002 of 11 November 2002 establishing the EUSF (including EUR 6,3 million already paid to Spain and Greece as advances).

The transfer also takes account of the agreement reached in the Conciliation on the 2022 budget to make an amount of EUR 211 million under the external strand of the SEAR available for the EUSF in 2022, which was compensated by a reinforcement of humanitarian aid by the same amount in the voted budget.
