	- Preparation for the trilogue

- 1. In view of the second trilogue on 26 November 2019, delegations will find attached a revised 4-column document reflecting the state of play of negotiations on the Creative Europe programme, as prepared by the Presidency. The document is based on the interinstitutional technical meetings held since the first trilogue (9 October 2019), namely on 14, 18 and 22 October and 6 November as well as the discussions in the Cultural Affairs Committee (CAC) on 21 October and 5 November 2019.
- 2. Delegations' attention is brought to the 4th column of the attached document, and in particular to the following lines (see numbers in the 5th column) which can be grouped in the following categories:

The elements listed under category 7 are the result of an additional bracketing<sup>4</sup> exercise undertaken after the first trilogue in order to ensure consistency across various programmes.

The above position has been discussed at working party level, with the exception of lines 193, 224 in category 2 (where the Council mandate is acceptable to the EP) and category 5, which contains three compromise proposals put forward by the Presidency to the EP after the latest working party meeting, in response to the concerns expressed by delegations.

3. The <u>compromise zone</u> reached so far in the technical discussions includes the Programme's **general and specific objectives** and **priorities** (Articles 3, 4, 5 and 6), as well as the **actions** through which the priorities of each strand, namely CULTURE, MEDIA and CROSS-SECTORAL, shall be pursued (Annex I). Most compromise proposals are hybrids between the Council mandate

and the European Parliament's position which bring about mostly technical and/or linguistic adjustments, with the substance being barely amended, if at all.

In the course of technical work, the co-legislators agreed to include a new paragraph on **European added value** to Article 3 of the Regulation (*Programme objectives*). The paragraph effectively defines how the European added value should be ensured and corresponds to the Council's and the Parliament's shared objective of emphasising the relevance of the concept for the Programme.

Discussions are ongoing on the addition of another horizontal paragraph to the same article, which would address inclusion and non-discrimination.

On Annex I, whose particular function is to provide additional information about the activities to be funded, the technical discussions between co-legislators have moved in the direction of adding an introduction to both the horizontal and sectorial actions under the CULTURE strand<sup>5</sup>, which was deemed appropriate for reasons of clarity.

In addition, technical discussions have also started on Article 2 (*Definitions*), Article 9 (*Cooperation with international organisations and the European Audiovisual Observatory*), Article 9a (*Data gathering on culture and creative sectors*), and Article 13 (*Grants*) as well as a number of recitals. Preliminary common ground found is signalled by text in the 4th column.

4. The two main <u>outstanding issues</u> in the negotiation process are the **governance** of the Programme and the **eligible entities**. On this latter matter, specifically concerning the European Youth Orchestra and the European Film Academy / LUX Film Prize, the technical level has decided to postpone discussion to a later stage.

Regarding governance, it is worth recalling that at the first trilogue, the European Parliament emphasised that it did not insist on implementing the Programme by way of delegated acts as such, but rather wanted to safeguard its prerogatives as co-legislator and guard against a change in the Programme's objectives and/or activities without its prior consent. The Presidency is willing to constructively explore options to find a solution in this regard, which would be legally valid and would preserve the interests of the Member States.

5. The <u>Permanent Representatives Committee</u> is invited to endorse a revised mandate as set out in the 4th column of the attached document for the second trilogue to be held on 26 November 2019.
