#### **STATEMENT 121/01**

# Re Decision as a whole

"The Commission recalls that, as a matter of principle, legislative acts must be clear, simple and precise, as provided for in the Inter-institutional Agreement on common guidelines for quality of drafting of Community legislation of 22 December 1998 <sup>1</sup>.

The Commission notes that Council and Parliament have agreed a text incorporating amendments that have not been revised to ensure they meet the abovementioned principles. Consequently, the Commission considers it useful to indicate the following:

#### Re recital 20

The purpose of the Decision is solely to introduce the list of priority substances as Annex X of the Water Framework Directive 2000/60/EC, as provided for by Article 16(11) of Directive 2000/60/EC. The Commission recalls that the requirements for the preparation of future proposals concerning priority substances are clearly set out under Article 16 of the Water Framework Directive 2000/60/EC.

#### Re Article 3

The Commission intends to implement the provisions of Article 3 concerning the provision by the Commission and Member States of data through the mechanisms provided for under Directive 2000/60/EC, in particular Article 16(5)."

# STATEMENT 122/01

#### Re Annex

"The Commission's proposal had envisaged that certain priority substances be subject to a review for identification as possible priority hazardous substances by 31 December 2003. A final decision was to be taken within the review of the list of priority substances provided for in Article 16(4) of Directive 2000/60/EC.

<u>The Commission</u> notes the agreement of the Parliament and the Council to require that this review and a Commission proposal must be submitted "not later than 12 months after adoption of this list".

While the Commission is willing to review the list as soon as possible, the wording agreed by Parliament and Council imposes too tight a framework for achieving the quality of work necessary for the task.

The Commission therefore reserves the right to meet this requirement in the light of technical feasibility and available resources."

# **STATEMENT 123/01**

# **Statement by the Council**

"<u>The Council</u> welcomes the Commission's stated intention to set up a group of experts from the Member States, with a view to facilitating and coordinating the transposition of the Directive into the national law of the Member States."

#### **STATEMENT 124/01**

### Re Article 4(1)

"<u>The Commission</u> states that, in accordance with the Fourth Company Law Directive, the expression of capital in euros does not necessarily imply that annual accounts must be drawn up in euros."

### **STATEMENT 125/01**

#### Re Article 17

"The Council and the Commission agree that the text of Article 17, as far as it refers only to certain types of merger defined in Articles 3(1) and 4(1) of the Directive 78/855/EEC, is without prejudice to future decisions on other legislative instruments in the area of company law and will be reviewed in the present instrument in the light of experience."

# STATEMENT 126/01

#### Re Article 58

"The Council and the Commission state that Article 58 covers all possible voting procedures, including shows of hands."

#### **STATEMENT 127/01**

#### Re Article 68

"The Council and the Commission state that this Article refers in particular to the case in which, because certain company structures do not exist under its national law, a Member State is obliged to adopt specific measures for the SE in order to implement this Regulation. The principle of non-discrimination between SEs and national public limited-liability companies should in any case be respected."

# **STATEMENT 128/01**

<u>Statement by the Commission concerning the possibility of integrating the Regulation on operations to aid uprooted people in Asian and Latin American developing countries into geographical regulations</u>

"The Commission intends to revise Council Regulation (EEC) No 443/92 <sup>1</sup> in the course of this year and submit its proposal to the Council and the European Parliament in the course of the first half of 2002.

The European Commission hereby declares that it will examine the possibility of integrating the uprooted-people Regulation into the new geographical regulations for Asia and Latin America."

## **STATEMENT 129/01**

#### Statement by the Council and the Commission

"In the light of the interim report on the use of Regulation No 723/97 during its first three years, the Commission had proposed a one-year extension of the existing legislation, notably in order that all Member States might benefit from an appropriate contribution to the implementation of new GIS systems.

Meanwhile, it has become apparent that the evaluation, initially by individual Member States and subsequently by the Commission, as provided for in Article 7 of Regulation No 723/97, covering the full 5-year period 1997-2001, cannot be completed before July 2002. Therefore, in order to allow sufficient time for a proper examination of such a report and any appropriate proposals by the Council and the European Parliament, it has been agreed to extend Regulation No 723/97 to include the year 2003 as well. This decision is without prejudice either to the content of the report or any subsequent position to be taken by the Council/the European Parliament on any possible future Commission proposals."

## **STATEMENT 130/01**

#### Statement by the Council and the Commission

"The Council and the Commission consider that the provisions of Article 19(7) should enable decisions to be taken on emergency vaccination by a method modelled on that used in managing the foot-and-mouth disease crisis."

### **STATEMENT 131/01**

#### Statement by the Austrian and German delegations

"Austria and Germany welcome the adoption of rules for combating classical swine fever, which they approve in principle. However, Austria and Germany oppose a general ban on swill for the feeding of pigs. In the control of epizootic diseases such as classical swine fever and foot-and-mouth disease, such a ban does not make it possible to guarantee a level of protection higher than adequate treatment according to an officially approved thermal process. This applies in particular to the risk from swill feed which has been produced at the agricultural holding itself or in the surrounding area.

The inclusion in the general ban on swill feed of catering waste from the area causes excessive pollution. This pollution clearly exceeds the risk posed by catering waste from the area when it is treated according to the rules. That is why Austria and Germany are in favour of a derogation for feedingstuffs containing catering waste from the area where compliance with the requirements imposed is guaranteed by administrative permits and stringent controls.

Since it has not been possible either to exclude catering waste from the area from the ban under the abovementioned conditions or to provide for adequate transition periods for undertakings processing this waste or using it in animal feedingstuffs, Austria and Germany have abstained when voting in order to obtain at least an appropriate and sufficient period for transposing the Directive into national law."

# **STATEMENT 132/01**

#### Statement by the Council and the Commission

Re Article 1(3)

"The Council and the Commission declare that the costs of actions which are laid down in Article1(3) will be fully covered by Community financing. The estimated amount needed for the implementation of the actions related to the mechanism is EUR 15 million for the years 2002 to 2006. The annual appropriations shall be authorised by the budgetary authority within the limits of the financial perspective."

### **STATEMENT 133/01**

# **Statement by the German delegation**

Re Article 1(3)

"The German delegation assumes that the sum of EUR 15 million for the years 2002 to 2006 referred to in the statement for entry in the minutes simply represents a maximum amount which is unlikely to be fully expended. The German delegation continues to regard a total of EUR 7,5 million as a realistic figure which should serve as a guideline."

#### Statement by the Italian delegation

Re Article 1(3)

"<u>The Italian delegation</u> believes that further consideration needs to be given to the cost of transport in order to make the mechanism operational."

"The Council and the Commission consider that particular attention should be paid, within the framework of the evaluation laid down in Article 10 of the Decision, to the way in which the Monitoring and Information Centre is fulfilling its task, with a view to transmitting any proposals for the possible development of that centre."

# **Statement by the Council and the Commission**

### Re Article 4(b)

"The Council and the Commission consider that in addition to the actions under Article 4(g), particular attention should be paid under Article 4(b) to the need for disseminating information on studies, research and development actions carried out at the level of both the Community and the Member States."

### **STATEMENT 137/01**

# Statement by the Representatives of the Member States, meeting within the Council

### Re Article 5(2)

"The Representatives of the Governments of the Member States, meeting within the Council, declare that, in the absence of any arrangement to the contrary between the Member States concerned, such as bilateral agreements, the costs of assistance rendered as laid down in Article 5(2) by the offering Member State shall be borne by the requesting Member State. The offering Member State may, bearing in mind in particular the nature of the disaster and the extent of the damage suffered by the requesting Member State, offer its assistance entirely or partially free of charge. An offer shall only be considered to be free of charge when this has been expressly stated. The offering Member State may also waive all or part of the reimbursement of its costs at any time."

#### **STATEMENT 138/01**

# Statement by the Council and the Commission

#### Re Article 6

"The Council and the Commission, being aware of the need to reinforce the capabilities for prompt assistance intervention outside the EC, and mindful of the particular role of the European Community Humanitarian Aid Office (ECHO), consider that it is desirable to improve cooperation in order to achieve optimal overall coherence between the mechanism and any of ECHO's activities in this area under Council Regulation (EC) No 1257/96 concerning humanitarian aid." <sup>1</sup>
