Subject:	Transfer of appropriations No DEC 29/2018 within Section III - Commission - of the general budget for 2018

1. On 29 October 2018, the Commission submitted to the Council proposal for transfer of appropriations No DEC 29/2018.

The purpose of this proposal is to transfer in commitment appropriations (c/a) an amount of EUR 7 million from Article 21 02 01 (*Cooperation with Latin America*), EUR 4 million from Item 23 03 02 02 (*Rapid and efficient emergency response interventions in the event of major disasters in third countries*) and EUR 16 million from Article 40 02 42 (*Emergency aid reserve*) to Article 23 02 01 (*Delivery of rapid, effective and needs-based humanitarian aid and food assistance*), as recorded in document 13690/18.

2. The transfer is being proposed in order to provide humanitarian assistance inside Venezuela, and to refugees and host communities in neighbouring countries to respond to significant and urgent needs in line with the Plan Compact for Venezuela issued in June 2018 for an amount of EUR 27 million in c/a.
