Following your letter of October 28 and considering the fact that a new Government was sworn in by the President Klaus Iohannis after winning a confidence vote in the Romanian Parliament on November 4, I would like to inform you that I have decided to withdraw the proposal concerning Mr. Victor Negrescu, as candidate for Member of the European Commission.

Moreover, I would like to forward you two proposals for the position of Member of the European Commission, both of them having the approval of the President of Romania:

- Mr. Siegfried Mureşan, Vice-Chair of the European People's Party Group in the European Parliament.
- Mrs. Adina Välean, Chair of the European Parliament Committee on Industry, Research and Energy

I strongly believe that both proposals meet the criteria of diverse and rich experience in the field of the European affairs and they will bring an important contribution to the successful work of the European Commission. I am also confident that either of these two would
