The Committee reached agreement on the compromise package proposed by the Presidency in the terms set out in 13610/13, namely:

- the text of the revised draft Council Decision on the signing, on behalf of the European Union, and provisional application of the Association Agreement between the European Union and its Member States, of the one part, and Ukraine, of the other part, with the exception of the provisions relating to the treatment of third-country nationals legally employed as workers in the territory of the other party, as contained in Annex I of document 13610/13;
- the Joint Declaration by the Council, the Commission, and the High Representative, as contained in Annex II of document 13610/13, to be inserted in the Council minutes at the moment of the formal adoption of the draft Council Decision on the signing and provisional application;
- the text of the accompanying draft Council Decision on the signing as regards certain Freedom, Security and Justice related provisions of the Agreement, as contained in Annex III of document 13610/13 with the understanding that this separate Council Decision and the Decision relating to the rest of the provisions of the Association Agreement, as referred to above, would be adopted at the same time;
- the text of the corresponding draft Council Decisions on the conclusion of the Agreement, as set out in Annexes IV and V of document 13610/13.

The Czech Republic recalled its request for the following declaration to be inserted into the minutes of the meeting:

"The Czech Republic holds the view that Council decisions adopted in accordance with Article 218 TFEU throughout the process of concluding the so-called mixed agreements should relate to individual agreements in their entirety. A splitting into two decisions, each of them referring to different articles of an agreement, does not seem to be necessary and could lead to cumbersome procedures.

The Czech Republic notes that the established practice has been so far to adopt only one Council decision relating to an agreement as a whole. With respect to the Case C-377/12 European Commission against Council of the European Union, pending before the Court of Justice of the European Union, we consider the modification of this practice as premature.

Furthermore, the Czech Republic maintains that Article 217 TFEU as a legal basis covers all the elements of the Association Agreement in its entirety. It is therefore not necessary to make use of the multiple legal bases."

A number of other delegations indicated that they would make declarations to the minutes of the Committee and/or the Council at the moment of formal adoption of the Council Decisions on signing and provisional application of the Association Agreement.

- a) **Proposal for a Regulation of the European Parliament and of the Council amending Regulation (EC) No 443/2009 to define the modalities for reaching the 2020 target to reduce CO<sub>2</sub> emissions from new passenger cars (First reading) (Legislative deliberation)**
  - b) **Proposal for a Regulation of the European Parliament and of the Council: Setting emission performance standards for new light commercial vehicles as part of the Community's integrated approach to reduce CO<sub>2</sub> emissions from light-duty vehicles (First reading) (Legislative deliberation)**
- **State of play**

The Chair informed the Committee that the period of reflection agreed under the IE Presidency was nearing to its end and invited delegations to indicate whether they were already in a position to offer their final views on the files. One delegation offered a number of comments on the final compromise reached, while indicating it still favoured a first reading agreement with the European Parliament. Two delegations and the Commission indicated they considered the final compromise balanced and therefore could support it. The Chair concluded that the Presidency would make a decision in the coming weeks on when to include the files in the Committee's agenda as "analysis of the final compromise text with a view to agreement".

= **"WIPO/EU coordination"**

The Committee took note of the information provided by the French delegation, aimed at raising delegations' awareness of recent developments in Geneva involving the management of the World Intellectual Property Organisation (WIPO).

Three delegations and the Commission welcomed the French delegation's call for enhanced coordination amongst EU Member States in view of the upcoming WIPO General Assembly.

= **Debrief of the Informal Meeting of Finance Ministers in Vilnius on 13-14 September 2013**

- The lunch started with the debriefing of the Eurogroup. Then Ministers discussed the aspects of the SRM identified by the ECOFIN President in the 10 September letter to ECOFIN colleagues.



- The meeting opened with an exchange of views on the current economic outlook, and financial stability. The discussion focused notably on the situation in the financial markets in the euro area and the EU, notably in the banking sector.
  - Ministers and Governors then exchanged views on the means to foster SME financing in the short and medium term. The discussion in particular focused on specifying the parameters of the SME financing instruments proposed by the European Investment Bank and the European Commission at the ECOFIN Council and European Council in June.
  - Ministers were then debriefed on the financial topics discussed at the G20 Heads of State summit at the beginning of September. They also touched on the agenda foreseen for the upcoming G20 ministerial and IMF/World Bank annual meetings and mandated the Economic and Financial Committee to prepare respective EU messages for these meetings.
  - The Ministers and Governors then discussed the measures required to ensure the stability of the banking sector as well as other policy steps and reforms necessary in the European financial system to help prevent and absorb any future shocks to the financial sector and reduce financial market fragmentation. The discussion was complemented by a presentation by the Brussels-based think-tank Bruegel.
  - Finally, there was a discussion on the recent initiatives at the EU and global levels related to the automatic exchange of information with the aim of tackling tax fraud and evasion more effectively. Ministers exchanged views on how actions could be better coordinated. The OECD's views were expressed by their guest speaker.

The Committee was debriefed by the Presidency on outcome of the informal trilogues with AFET and DEVE Committees of the European Parliament and informed about the intended handling of the file.
